
The centerpiece of this ranch is the 17-Acre private spring fed fishing/recreational lake. The fishing is reported to be exceptional with largemouth bass, catfish, bluegill and black crappie, all found in abundance. There is a fishing dock that extends out into the lake, and there is also a swimming platform anchored in the middle of the lake.








This attractive ranch has diverse topography that ranges from virtually level to gently sloping country, descending to slightly broken areas along seasonal draws and creeks. The ranch is a combination of improved Coastal flats, native rangeland and heavily wooded areas, which provide excellent habitat for wildlife. The Coastal fields are scattered throughout the ranch and are currently cut for hay production. The native rangeland portions of the ranch have an excellent stand of grass turf that is comprised of Little Bluestem, Indian Grass, Side-oats Gramma, Texas Winter Grass, Seep Muhly, Purple Three-awn, Silver Bluestem, Arizona Cottontop, Curly Mesquite, Hairy Gramma and Sand Dropseed, to name a few. The heavily wooded areas throughout the ranch are made up of a mix of Postoak, Ash Juniper, Mesquite, Blackjack Oak, Cedar Elm, and Hackberry trees.

The ranch is located in an area with a generally desirable climate and an annual precipitation in the range of 35-36 inches.


The Clayton Ranch offers great hunting opportunities with game species that include whitetail deer, turkey, quail, dove and feral hogs. Parker County is currently a two buck, two doe county.



There are two homes on the property. The first is a three bedroom/ two bath cabin near the lake that features a kitchen, living room and sunroom. There is a wooden deck off the front of the house that looks out over the lake. The cabin is older, but in good shape. The second home is located fairly close to the entrance of the property. There are four water wells located on the property.






