
Rolling mature timber with gorgeous views.

Buildings/Improvements

This property includes a 42' x 80' Lester shop that was built in 2007. Building includes a 34 bathroom, kitchen and wood burning fireplace with gas starter. The shop has 16' side walls and four overhead doors. The building is entirely insulated and heated. The living area is heated with radiant heat and the storage area is heated with a forced air LP furnace. The north portion is used for living quarters and the south portion is used for equipment storage. There is a 12' x 27' area used as a living area/bedroom and is air conditioned. 
Plat Map

There is a newer drilled well located northeast of the shop. The septic tank and leach field is located directly north of the shop.

LP Tank

The 500 gallon LP tank is owned and will stay with the property.

Creek

Plum Creek crosses through the west portion of this farm. This is a beautiful spring-fed creek that is clear and full of fish.


Comments


