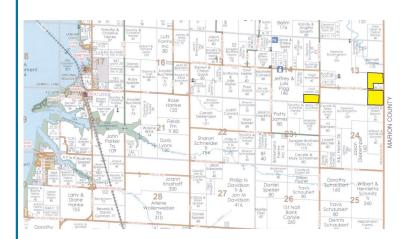
GENERAL DESCRIPTION

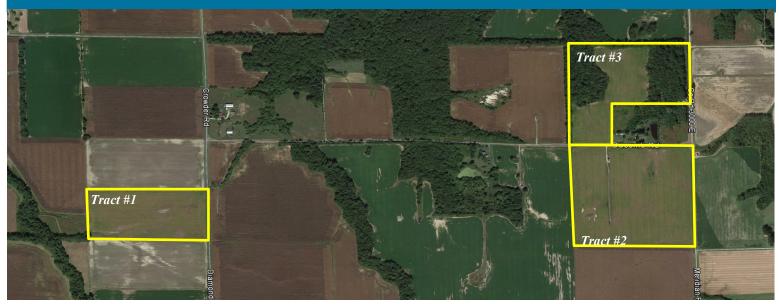
<u>Tract #2</u> features 40.0 tax acres and is 98% tillable with 39.03 acres of cropland. Great soils, and another great addition to an operation.

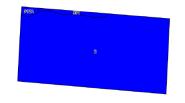

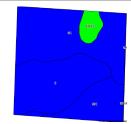

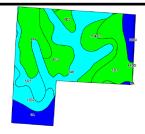
