 - Lessor only shares this portion of expenses as long as current soils analysis indicating soil has a pH of 5.6 or higher.
- Wheat, Oats, Corn, and Milo: 1/4th with Lessor sharing some expenses.
 - Shared expenses: 1/4th of fertilizer and insecticide.
- Rice: 1/5th net. Lessee pays all expenses related to production of rice crop.
- Irrigation: Lessor furnishes wells and pumps without power source or utilities.
- All USDA payments, including any Conservation Stewardship Program (CSP) that may be in place, Lessor is entitled to 1/5th of payments.






