CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. F. BAIRD.

, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamiil River Oregon Yamnill River, a tributary of Willamette River for the purpose of a tributary of of the State Engineer, and that said right to the use of said waters Irrigation has been perfected in accordance with the laws of Oregon; that the priority of the right hereby June 30, 1942 confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SHI, Section 36, Township 5 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 1.4 ucres in the NE; SW4, as projected on D.L.C. 48 6.4 acres in the NE SW4, as projected on D.L.C. 57

1.4 acres in the NW; SW; as projected on D.L.C. 57 Section 36

T. 5 S., R. 6 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a stake set at the Northeast Corner of lend belonging to Henry Hammann as per deed recorded on May 28th, 1908, in the record of deeds for Yambill County, Oregon, at Page 552 of Vol. 50 of said records; thence South 65 10' East 2.33 chains; thence South 13.67 chains to street; thence West 2.12 chains to the Southeast corner of the dammann's Land; thence North 14.65 chains to the place of beginning, containing 3 acres, all in Yambill County, Oregon, and Lot 1 & 2 of East Sheridan Subdivision.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
