The subject property is currently zoned Rural Preservation (RP). There are approximately 1,970 feet +/- of road frontage on State Route 656 (Colemans Mill Road) and 2,850 feet +/- on State Route 684 (Dry Bridge Road).

The subject property contain 28 acres +/- of cropland with the balance in recently cut-over woodland.

It is located convenient (2.3 miles +/-) to Interstate 95 (Exit # 104) and 1 mile from Route 207 (Rogers Clark Blvd). It is also located adjacent to the Spratt Commercial Park. 




TOPOGRAPHIC MAP




ZONING MAP
