

TRACT 1:

5.757 Acre Tract: All that certain tract or parcel of land situated in Cass County, State of Texas, a part of the Jas. Hamilton Survey A-462 and being a part of that 44 acre tract conveyed by Harriett Lemmons to Kizzie Davis as recorded in Vol. A-9, p. 468 of the Deed Records of said County and being that same 44 acre tract conveyed by Sheriffs Deed from James D. Estess, Sheriff of Cass County to Leanna Ruth Harrison or Joseph Strobel (Vol. 1205, p. 650) and bounded as follows:

BEGINNING at a typical steel rod (typical steel rod is a ½" x 24" steel rod with surveyor's cap marked "Hampton") set in the west boundary line of the Hamilton Survey and the east boundary line of the Samson Cuthbirth Survey A-210 at the called northwest corner of the aforementioned 44 acre tract and the apparent most westerly southwest corner of that 62 1/3 acres described in three tracts in that Oil, Gas and Mineral Lease conveyed by Joe Harris and Ora M. Harris to C. C. Davis (Vol. B-9, p. 582), said beginning corner lays in the east boundary line of that 15 3/5 acre Tract No. 5 allotted to George Jackson in that Partition Deed recorded in Vol. 635, p. 765 (Reference Deed at Vol. 622, p. 432), said beginning corner bears S 2° 48'34" W, 50.63 of a 1" x ½" steel stake found at the apparent northeast corner of the aforementioned 15 3/5 acre tract;

BEGINNING at 1/2" iron rod found in South boundary Robert Hamilton Survey, Abstract No. 463 at Northeast corner Samson Cuthbirth Survey, Abstract No. 210 and Northwest corner James Hamilton Survey and Northwest corner 26 1/6 acres for Northwest corner;

THENCE: S 89° 45' 27" E, 1768.98 feet with South boundary Robert Hamilton Survey and North boundary James Hamilton Survey and North boundaries both 26 1/6 acres to 60d spike set at base pine stump and old fence corner at Northwest corner Ivory Craig James et al tract (F-5/94) and Northeast corner other 26 1/6 acres for Northeast corner;
