CORYELL COUNTY

All that certain tract or parcel of land situated in Coryell County, Texas being 164.395 acres of land out of the A. B. Fleury Survey, A-356 and being a part of that 306 acre tract described in Deed to Robert Stanley Sugg, et ux, Patsy Sue Sugg per Vol. 553, page 153, Coryell County Deed Records, said 164.395 acre tract described by metes and bounds as follows;

BEGINNING at a steel pin set at the base of a corner post being in the South line of U.S. Highway No. 84 an occupied NEC of said 306 acre tract and the NEC of this;

THENCE S16-13-35W (All GPS Bearings) along an old wire fence, at 4410 feet passing a 30 inch Burr Oak tree, at 4611.64 feet a point in the center of Cowhouse Creek, the SEC of this;

THENCE up and along the centerline of same with its meanders as follows;

N28-38-44W, 269.78 feet,

N58-18-12W, 356.33 feet,
