





CERTIFICATE OF SURVEY: CERTIFIED BOUNDARY SURVEY

I hereby certify only to the parties named hereon that we have surveyed and divided into several parcels, at the direction of said parties, a parcel of land previously described as:

Legal Description (as provided): The North fraction of the Southwest quarter of Section 19. T5N, R4W, in Eagle Township, Clinton County, Michigan, EXCEPT for the following parcel: That part of the North fraction of the Southwest 1/4 of Section 19, T5N, R4W, lying North of the Grand River, described as: Commencing at the West 1/4 corner of said Section 19; thence South 1329.0 feet on the West line of said Section 19; thence East 33 feet; thence S54°15'40"E, 414 feet; thence Southerly along the North bank of the Grand River to the West line of Section 19; thence North along said West line to a point 1329 feet South of the West 1/4 corner of said Section 19; thence East 33 feet; thence N57°29'E, 8 feet to the point of beginning. Together with rights of ingress and egress from Clintonia Trail over a 30 feet private drive and subject to rights of ingress and egress of others over a 30 feet private drive on the Northwesterly side of the above described parcel. PARCEL B: CERTIFIED BOUNDARY SURVEY

PROPOSED INGRESS & EGRESS EASEMENT BENEFITTING PARCEL C:

Part of the Southwest 1/4 of Section 19, T5N, R4W, Eagle Township, Clinton County, Michigan, described as: A 50.00-foot wide strip of land, the boundaries of which being 25 feet on either side of the following described centerline: Commencing at the West 1/4 corner of said Section 19; thence S00°15'31"W along the West line of said section a distance of 469.48 feet to the point of beginning of this centerline description; thence N86'41'20"E 350.54 feet; thence N88'30'13"E 401.09 feet; thence Southeasterly 69.29 feet along a tangent curve to the right, said curve having a radius of 100.00 feet, a delta angle of 39° 42'01" and a chord of 67.92 feet bearing S71'38'47"E; thence S51'47'46"E 34.78 feet; thence Southeasterly 51.27 feet along a tangent curve to the left, said curve having a radius of 100.00 feet, a delta angle of 29'22'32" and a chord of 50.71 feet bearing S66'29'02"E; thence S8110'18"E 94.45 feet; thence Southeasterly 75.83 feet along a tangent curve to the left, said curve having a radius of 500.00 feet, a delta angle of 8'41'22" and a chord of 75.76 feet bearing S85'30'59"E; thence S89'51'40"E 162.26 feet to the west line of Parcel C and the point of ending; the boundaries of said 25-foot offset lines from this centerline description are to be extended or shortened to at angle points and to meet the west boundary line of Parcel C and also to meet the west line of said Section 19; the northerly 25-foot offset from this centerline description shall also be lessened where the distance between the centerline description and the northerly boundary of said Parcel B is less than 25 feet, the extents of the easement shall not intrude on the property to the north of Parcel B; said easement subject to all other easements and restrictions if any.
