BEGINNING at a 5/8 inch iron rod capped #2320, set at the intersection of the West line of COUNTY ROAD NO. 137 (WALTERS ROAD) (meas. 60 ft. wide), and the extension of the South line of COUNTY ROAD NO. 146 (MELTON LANE), for the **Southeast corner** hereof; from which corner, a 1½ inch iron pipe called & found at the intersection of the North line of said COUNTY ROAD NO. 146, and the Extension of the East line of said COUNTY ROAD NO. 137, bears, South 69 Deg. 55 Min. 00 Sec. East, 60.00 ft. and North 20 Deg. 00 Min. 00 Sec. East, 50.00 ft.;

THENCE North 69 Deg. 55 Min. 00 Sec. West, at 743.16 ft. pass a 5/8 inch iron rod capped #2320, set on the high bank of PEACH CREEK, at 898.13 ft. pass another 5/8 inch iron rod capped #2320, set on the bank of PEACH CREEK, and in all, 936.1 ft. to a point in the centerline of said PEACH CREEK, same being in the Northwest line of said 13 1/3 Ac. tract, for the Southwest corner hereof;

THENCE downstream, with the centerline of said PEACH CREEK, same being with the Northwest line of said 13 1/3 Ac. and said 16 ½ Ac. tracts, the following courses:

North 85 Deg. 32 Min. 13 Sec. East, 105.0 ft. to a point at the intersection of the West line of said COUNTY ROAD NO. 137, with said centerline of said CANEY CREEK for the Northeast corner hereof;

THENCE South 20 Deg. 00 Min. 00 Sec. West (Reference Bearing), with the extension of the West line of said COUNTY ROAD NO. 137 (roadway not open), at 37.8 ft. pass a 5/8 inch iron rod capped containing 22.12 Ac. of land.
