

All that certain tract or parcel of land situated in Coryell County, Texas, out of the R. W. Wade Survey, Abst. No. 1064, being all of the land Edna Hampton, a widow, conveyed to C. B. Whatley by Warranty Deed dated April 22, 1971, recorded in Coryell County Deed Records Vol. 284 pg, 268, a part of the FIRST TRACT and all of the SECOND and THIRD TRACTS conveyed from F. C. Franks, et al, by Warranty Deed dated January 19, 1964, recorded in said Deed Records Vol. 239, pg 108, and described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron pin set for the Southeast corner of this tract at the Southwest corner of 14.99 acres conveyed to Hugh Richard Penny (307/873), said corner bears North 71° West 1600 feet and North 57° 50' West 609.4 feet from the Southeast corner of said Wade Survey;

THENCE: along and with a common fenceline with Truett W. Bates, et ux, (436/164), North 57° 59' 17" West 377.04 feet to a 1/2 inch iron pin set for an angle point at a cedar fencepost and North 70° 10' 57" West 925.51 feet to a 1/2 inch iron (continued on 70° 10' page)

pin set for the Southwest corner of this tract, same being the Southwest corner of said Hampton/Whatley tract and Bates' Northwest corner in the East line of 41.215 acres Billy W. Spivey has on a Contract of Sale and Purchase (356/234)'

- THENCE: along and with said East line, North 19° 03' 14" East 152.87 feet to a 1/2 inch iron pipe found for a Southwest corner of 8.618 acres conveyed to Kennith Lynn Doyle (July 12, 1995, Doc. #90866), same being an outside corner of this tract and said Hampton/Whatley tract;
- THENCE: South 70° 41' 34" East 324.21 feet to a 1/2 inch iron pipe found for the Southeast corner of said 8.618 acres, same being an ell corner of this tract;
- THENCE: North 12° 43' 47" East 492.26 feet to a 3/8 inch iron pin found for an angle point in East line of said 8.618 acres, same being the West line of this tract;
- THENCE: North 19° 53' 28" East 442.78 feet to a 3/8 inch iron pin found for the Northeast corner of said 8.618 acres in the South right of way of F.M. Hwy 183, same being the Northwest corner of said THIRD TRACT and this tract;
- THENCE: South 70° 08' 00" East (Record bearing 284/268), with said right of way, 1017.50 feet to a 1/2 inch iron pin set for the Northeast corner of this tract at Penny's (307/873) Northwest corner;
- THENCE: South 19° 06' 08" West 1165.89 feet, with Penny's West line, to the place of beginning and containing 26.485 acres of land.
