2. We are familiar with the Property and with the improvements located on the Property.

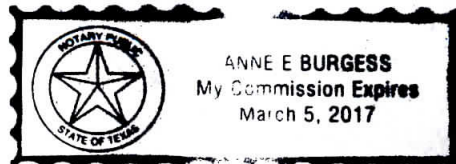

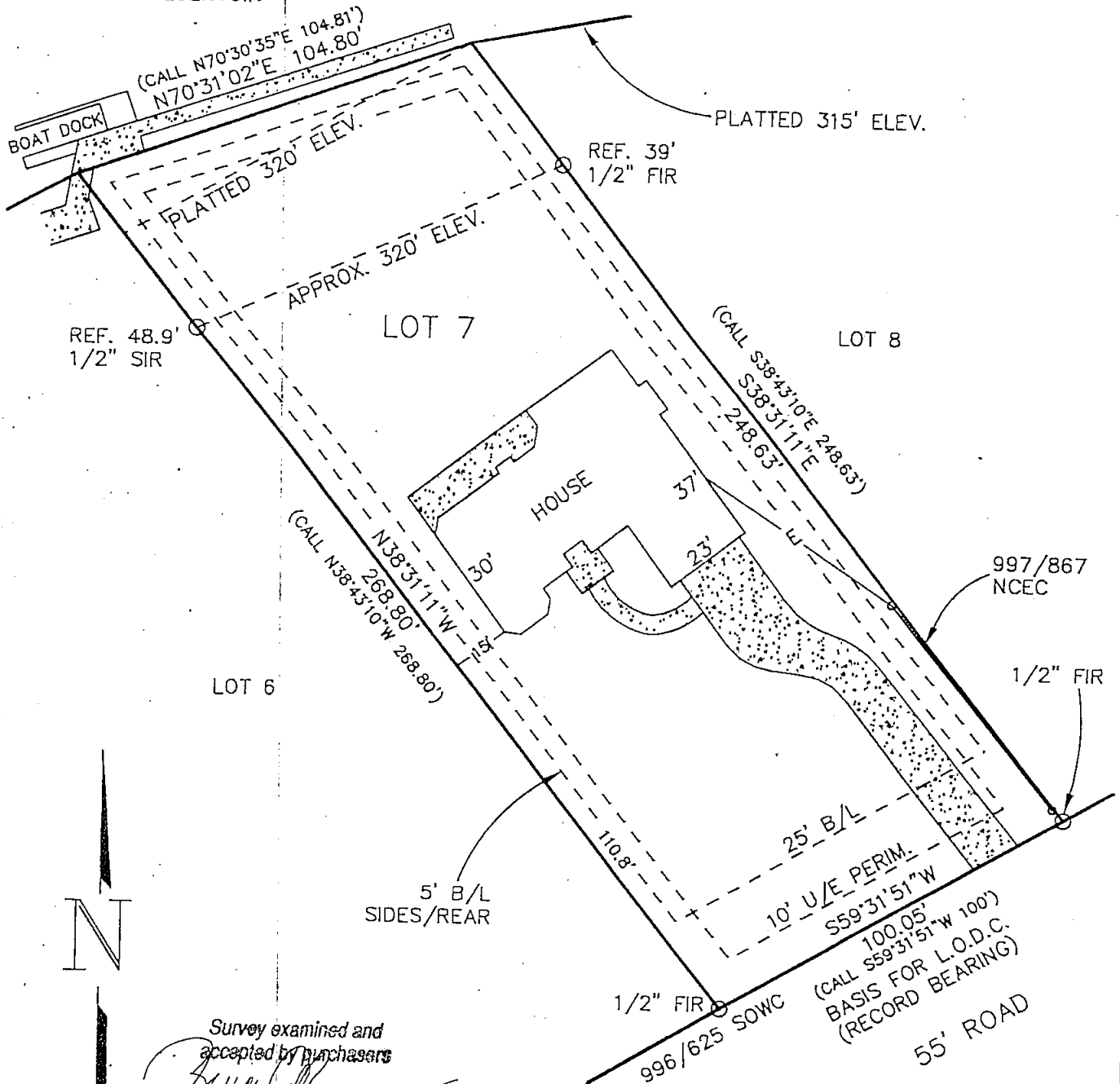
