- Inat each of the parties hexeto and their guests shall have free use of all parts of the said lake for boating, fishing, swimming, skating and general recreational purposes.
- 2. That boating will be limited to non-motorized craft only, except for electric trolling motors.
- 3. Inst to the extent maintenance of the lake dam or spillway becomes necessary, or stocking it lake is designed, each property owner agrees to be responsible for one-third of all expenditure made in that regard, provided that the parties shall discuss and agree upon such expenditure prior to any costs being incurred. The parties also agree to share equally the costs of fulfilling any legal requirements regarding the dam, such as inspection and reports, also subject to gior discussion and agreement.
- 4. That this agreement shall be binding upon and inure to the benefit of the respective parties, they have, successor and assigns.
