Reynolds by deed dated August 31, 1990 and recorded at Volume 200 Page 822 of the Mills County Dead Records, the Southwest corner of said Strizek tract and the Southwest corner hereof;

THENCE, NO0°00'00"W, (bearing basis) 2635.59 feet to an iron rod set which bears North, 12.5 feet from a fence post and West 6.0 feet from a second fence post at the intersection of fence lines for the center point of said Section 51 and the Northeast corner of said Reynolds "First Tract", the Southwest corner of Reynolds "Second Tract", the Southeast corner of D.T. Medford and Goforth tract, the Northwest corner of said Strizek tract and the Northwest corner hereof;

Tiemann by deed dated February 27, 1970 and recorded at Volume 135 Fage 767 of the Mills County Deed Records, the Northeast corner of said Strizek tract and the Northeast corner hereof;

THENCE, along the common line with said Section 4 and said Tiemann tract, \$00°05'05'W, 1299.96 feet to a fence post found in the Western right-of-way of said highway 16 as the South corner of said Tiemann tract and the Northern point of the referenced Right-of-Way tract recorded in Volume 117 Page 179, then with said highway 16 ROW and a curve to the left with radius of 4539.51 feet, central angle of 09°46'00", arc length of 773.80 feet, and a chord length of 772.87 feet which bears \$04°23'16"W to a concrete marker as end of said curve, \$05°52'20"E, 154.30 feet to a fence post as angle point and \$01°04'15"W, 440.79 feet to the POINT OF BEGINNING and calculated to contain 161.351 acres therein.
