FOR AND IN CONSIDERATION OF the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and confessed, FRED T. OWEN, JR., of the County of Bosque, State of Texas (AGrantore), has GRANTED, SOLD, CONVEYED and DELIVERED, and by these presents does hereby GRANT, SELL, CONVEY and DELIVER unto OLEY F. HEDRICK, JR. and Rachel O. Hedrick, as Trustees of the Oley F. and Rachel O. Hedrick Living Trust dated December 28, 1989, and as subsequently amended, or to any successor Trustee or Trustees thereto, located at P. O. Box 463, Midland, Texas 79702-0463, of Midland County, Texas and to SPIRE PETROLEUM CORPORATION, a Texas corporation located at 10709 Marsh Lane, Houston, Texas 77024, of Harris County, Texas, (collectively, AGranteese), an exclusive and permanent easement for a pipeline for the transportation of water, which easement is fifteen (15) feet in width, or seven and one-half (7.5) feet on either side of a centerline, the course of which is more particularly described on the attached Exhibit A, which includes a metes and bounds description thereof as well as a plat of the same, both of which are made a part hereof for all purposes (the @Easement@), and which Easement@ies over and across the following described lands located in Bosque County, Texas, to-wit (the ALands@):

FIRST. 17.849 acres of land, more or less, located in the Gertrudis Cherino Survey, Abstract No. 119, which tract of 17.849 acres is described in that certain Partition Deed to Fred T. Owen, Jr., which is recorded in Volume 266, page 957, Deed Records, Bosque County, Texas, and being a part of the tract described in a Deed from Myra Baker, et al, to Nena Greenwade Owen, dated February 20, 1915, and recorded in Volume 72, page 59, Deed Records, Bosque County, Texas;

- SECOND. 325.96 acres of land, more or less, described in that certain Deed dated January 22, 1975, from Charles Owen, et al, to Fred T. Owen, Jr., which is recorded in Volume 230, page 958, Deed Records, Bosque County, Texas; and
- THIRD. The remainder of a 356.23 acre tract of land described in a deed dated January 23, 1976, from Charles H. Owen to Dennis Owen recorded in Volume 235, page 72, Deed Records, Bosque County, Texas, and a quitclaim deed dated October 22, 1981, from Dennis Owen, et al, to Charles Owen, recorded in Volume 267, page 553, and Volume 264, page 855, Deed Records, Bosque County, Texas.

The Easement shall be deemed to include the right to install such pumps and power facilities for the operation thereof as may be reasonably necessary in order to operate a pipeline for the transportation of water over the Lands, and Grantee shall be entitled to enter upon the Lands in order to gain access to the Easement for such maintenance and repairs thereon as may be needed from time to time.

TO HAVE AND TO HOLD the Easement, together with all rights and privileges thereunder pertaining and otherwise belonging unto Grantees and to Grantees= successors and assigns forever, and Grantor does hereby bind Grantor, and Grantor=s personal representatives, heirs, successors and assigns to warrant and forever defend all and singular the Easement, together with all rights pertaining thereto, unto Grantees and Grantee=s successors and assigns, against every person whomsoever lawfully claiming or to claim the same of any part thereof; provided, however, that Grantor, and Grantor=s successors and assigns shall have the right to cross over the Easement via roads on the Lands, and to build roads which cross over the Easement, without notice to or compensation of Grantee; provided, however, that in the event that Grantor, or Grantor=s heirs, successors or assigns damage or cause damage to any pipeline of Grantees, Grantor shall, upon demand, pay damages to Grantees caused by such damage or make all necessary repairs to restore the pipeline to its status before any damage thereto.

Notwithstanding any of the foregoing, in the event that Grantees, their successors or assigns cease to operate a pipeline for the transportation of water as provided by this Easement for a period of ten consecutive years, such Easement shall expire and revert to Grantor, their successors or assigns.
