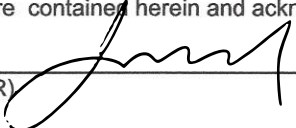

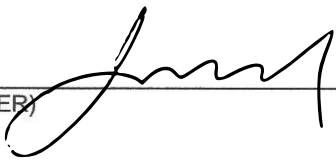

BUYER is advised that school boundaries are subject to change.
