

All that certain lot, tract or parcel of land, part of the N. Robins Survey, Abstract No. 440, Kaufman County, Texas, all of that certain tract conveyed to Jack Richard Grimes by Leona Elizabeth Grimes, et al on May 8, 1973, recorded in Vol. 578 page 710 of the Deed Records of Kaufman County, Texas and being more completely described as follows, to-wit:

BEGINNING at a 3/8" Iron rod found at the West corner of the above mentioned tract, recorded in Vol. 578 page 710, at the South corner of the Kenneth Mathis 2.000 acre tract, recorded in Vol. 1089 page 657 of the Deed Records of Kaufman County, Texas and being in the Northeast line of Oak Hollow Phase II, recorded in cabinet 2 page 360 of the Plat Records of Kaufman County, Texas.

THENCE N 45 deg. 00 min. 01 sec. E, with the Northwest line of said tract, recorded in Vol. 578 page 710, a distance of 2568.40 ft. to a 3/8" Iron rod found at the intersection of same with the Southwest Right of Way line of Farm to Market Road No. 1389 and being in the Southeast line of the Chad Kevin Mathis 13.979 acre tract, recorded in Vol. 1089 page 650 of the Deed Records of Kaufman County, Texas.

THENCE S 45 deg. 28 min. 39 sec. E, with the Southwest Right of Way line of Farm to Market Road No. 1389, a distance of 633.08 ft. to a 3/8" Iron rod found at the intersection of same with the Southeast line of said tract, recorded in Vol. 578 page 710 and being in the Northwest line of the Floyd D. Grimes tract, recorded in Vol. 578 page 718 of the Deed Records of Kaufman County, Texas.

THENCE S 45 deg. 00 min. 00 sec. W, with the Southeast line of said tract, recorded in Vol. 578 page 710, a distance of 2569.87 ft. to a 3/8" Iron rod found at the South corner of same, at the West corner of said tract, recorded in Vol. 578 page 718 and being in the Northeast line of the above mentioned Oak Hollow Phase II.

THENCE N 45 deg. 20 min. 40 sec. W, with the Southwest line of said tract, recorded in Vol. 578 page 710, a distance of 633.08 ft. to the point of beginning, containing 37.338 acres of land.
