The Highway 57 Tract is described as W½ of NW¼ of SE¼, Section 16, Township 13 South, Range 19 West, containing 20 acres, more or less, Ouachita County, Arkansas (see attached maps).

It was chemically treated to control herbaceous competition in March of 2000, resulting in a well-stocked, industry-grade plantation that is ready for a first thinning. The remaining acreage contains a hardwood bottom along a branch of Lewis Bayou.

Based on owner's timber volume estimates, the pine plantation includes approximately 126 tons of chip-nsaw and 358 tons of pulpwood. The creek bottom includes 78 tons of hardwood sawtimber and 150 tons of hardwood pulpwood.






