N 78° 09' 25" E 63.39' to a 5/8" rebar set in line, the same course continued 104.71' further for a total of **168.10'** to a 5/8" rebar set on the northeast brow of a ridge, thence running off the ridge

Lot 2, and Lot 3, of Evans Acres, (the original corner was destroyed by road construction), thence leaving Lot 1 and Lot 3 and running with a portion of the original line between the 120 acre tract and Liller, and angling across the north side of Magnolia Drive by Steven R. Liller, (Deed Book 322, Page 514) and the residue of a 44 acre tract which is also N 37° 00' 31" E 304.08' to a 5/8" rebar set in line on the southwest side of Magnolia Drive, the same course continued 20.15' further for a total of **324.23'** to a point in the road, in an original owned by JDM Excavating and Construction, LLC, also being a division corner between Lot 1, line of the 120 acre tract of which this is a part and at a corner between a 25.38 acre tract owned

S 49° 44' 14" E 283.95' to a point in the 50' right-of-way, thence leaving Liller and the original
