Mr. Holland I have answered all the questions on the forms that I know. In several places I wrote see attachment, I will try to answer all here.

The septic tank is under the driveway in the rear of the house, just south of the bathroom, and bedroom windows. A new tank was installed by Paul Rains, I am not sure who did the connections though or the date it was installed but I think it was in the 90's or early 2000's.

The city water line crosses the road just east of the west property line then angles from there to the cutoff by the west window. The meter is just east of the high line pole across the road from the driveway. Danny is paying the water fee and has run a line from the house south to the windmill area.

Danny has repaired most of the fence surrounding all the pastures and from the north to the south along the west property line I was told. It was up last spring when I drove around the turn-rows of the north and south fields. Danny has run some cattle on it since he got water there.

The windmill should still be a good well but the mill itself is bad, stripped gears. The well at the house I think is sanded in and the pump has been moved I think. There are 3 cisterns. The one between the house and the garage had plenty of water when I was last there and is hooked up to a pump and tank that is in the cellar. The power to the pump is in the garage. There are valves in the cellar and I think also under the house that my dad installed where he could use water from either cistern in the house but I don't remember which valve or line is which.


The propane tank belongs to the farm as far as I can remember. It replaced the old underground butane tank the sits south of the shop I think in the early 50's. I would warn anyone who buys that if they want to do anything with that old butane tank to use extreme caution with flames around it just to be safe. The line from the propane tank I believe is copper as is most of the plumbing in the house I think.

There are 2 trash dump sites on the place that I know of. One is on the south end of the pasture just east of the house and the other is on the north side of the main pasture, east of the windmill.

The house has several repairs needed, The doors for the shop fell in, The shop and the well house both have 220V. The south gutter and wood is in need of repair as is the wood on the north side of the garage. There has been a roof leak on the house and it may need a new roof. The garage roof is several years newer than the house roof. There is ceiling damage in several places in the house. There is some damage to the north wall in the living room below the west end of the picture window.

All appliances were working when I last used them.
