By filing this form, the new owner agrees to comply with the management plan for the land and the managed forest land program rules. Changes that a landowner makes to property that is subject to an order designating it as managed forest land, or to its use, may jeopardize benefits under the program or cause the property to be withdrawn from the program and may result in the assessment of penalties.
