According to the tax records the property contains 74.27 acres +/-; however, the deeded acreage is 74.9 Acres +/-. The original deed is recorded in Deed Book 186 on Page 562 and a subsequent deed is recorded in Deed Book 280 on Page 80. A review of the Mecklenburg County Tax Records indicates the following:

The subject property is currently zoned Agricultural (AG). There are approximately 950 feet +/- of road frontage on State Route 734 (Cherry Hill Road).

There is an old house located on the subject property; however, it doesn't add any appreciable value to the property.

Jamison Branch meanders through the subject property and eventually into Buffalo Creek. The property also contains a 3/4-acre pond and a one-tenth of an acre pond.

It contains approximately 23 acres of fallow openland/hay fields with the balance in woodland. The woodland consists of some young natural pine regeneration, about 43 acres +/- of 8-year old pines (per VDoF records) and a scattered mixture of pine and hardwood pulpwood on the balance.




