

YOU MAY BE SUBJECT TO INCONVENIENCES OR DISCOMFORTS ARISING FROM AGRICULTURAL RELATED OPERATIONS, INCLUDING BUT NOT LIMITED TO NOISE, MACHINERY OF ANY KIND DURING ANY 24 HOUR PERIOD (INCLUDING AIRCRAFT), THE STORAGE AND DISPOSAL OF MANURE, AND THE APPLICATION BY SPRAYING OR OTHERWISE OF CHEMICAL FERTILIZERS, SOIL AMENDMENTS HERBICIDES AND PESTICIDES. THE TOWN BOARD HAS DETERMINED THAT THE USE OF REAL PROPERTY FOR AGRICULTURAL OPERATIONS, PARTICULARLY IN THESE DESIGNATED AREA, IS A HIGH PRIORITY AND FAVORED USE TO THE TOWN. HOSE INCONVENIENCES OR DISCOMFORTS ARISING FROM AGRICULTURAL OPERATIONS, IF SUCH OPERATIONS ARE CONSISTENT WITH NORMAL FARMING PRACTICES FOR THE REGION AND COMPLY WITH LOCAL, STATE AND FEDERAL LAWS, SHALL NOT BE CONSIDERED A NUISANCE.
