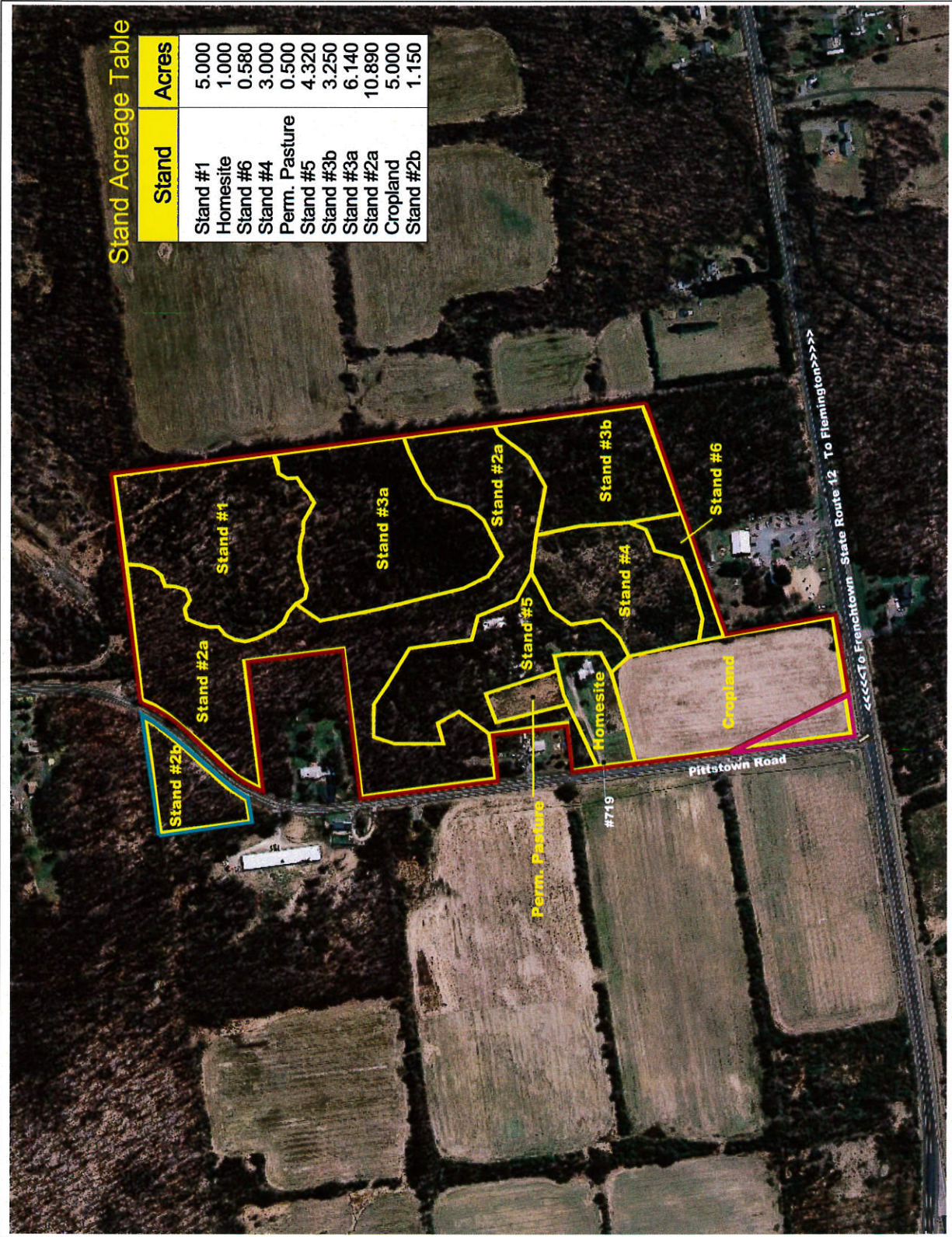


Goodman Property Stand/Activity Map

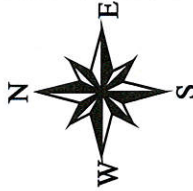
