All that certain tract or parcel of land situated in Hamilton County and Comanche County, Texas being 116.507 acres of land out of the J. B. Walden Survey, A-857 Hamilton County and A-989, Comanche County and being all of that 115 acre tract described in Deed to John M, Tucker and wife, Barbara Tucker per Vol. 196, page 345 Hamilton County Deed Records said 116.507 acre tract described by metes and bounds as follows;

BEGINNING at a steel pin set in a wire fence being in the East line of an old Hamilton County Road, the NEC of said 115 acre tract and the NEC of this;

THENCE S19-48-29W (all GPS Bearings) along fence, at 197.05 feet a steel pipe for a corner post, an interior corner of this;

THENCE \$16-28-27W along a wire fence, at 1480.21 feet a steel pin found, an exterior corner of this;

THENCE S53-12-06W 15.56 feet to a steel pipe found for a corner post, an interior corner of this;

THENCE \$16-39-43W along fence, at \$47.86 feet a steel pin set, the SEC of this;

THENCE N72-36-38W, at 32.0 feet a steel pin found with Pfingston RPLS cap the NEC of an adjoining 556.26 acre tract described in Deed to Morgan Purvis per Vol. 761, page 436 Comanche County Deed Records, and continue same course at 415 feet crossing into Comanche County, at 2019.54 feet a steel pin found with Pfingston cap at the base of a corner post, the SWC of said 115 acre tract and the SWC of this;

THENCE N17-24-51E along fence at 1392 feet crossing into Hamilton County, at 2518.36 feet a steel pipe found, the NWC of this;

THENCE \$73-09-10E along fence, at 2001.56 feet the Point of Beginning and containing 116.507 acres of land of which 25.129 acres lie in Comanche County and 91.378 acres lie in Hamilton County.
