LEAD-BASED PAINT DISCLOSURE

Federal law mandates that Sellers of housing constructed prior to 1978 must complete certain Lead-Based Paint Disclosure requirements. These should be completed before the Buyer makes an offer and certainly before the Seller accepts a purchase offer, otherwise the Buyer may not be obligated under any contract to purchase such housing.

Lead poisoning in young children may produce permanent neurological 8 9 damage, including learning disabilities, reduced intelligence quotient, behavioral problems, and impaired memory. Lead poisoning also poses a particular risk to pregnant women. The Seller of any interest in residential 10 real property is required to provide the Buyer with any information on lead-based paint hazards from risk 11 assessments or inspections in the Seller's possession and notify the Buyer of any known lead-based paint hazards. 12 A risk assessment or inspection for possible lead-based paint hazards is recommended prior to purchase. 13
