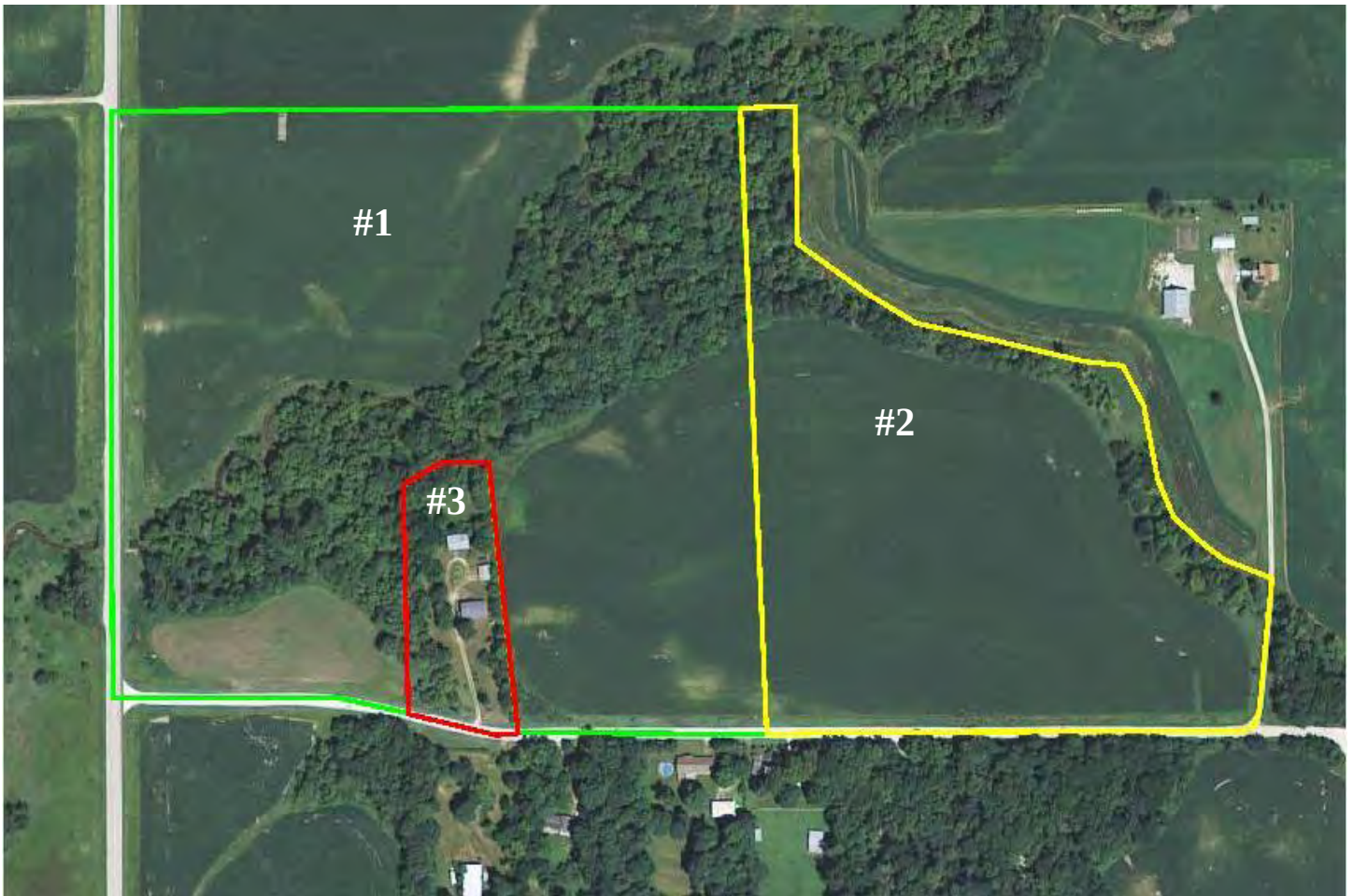

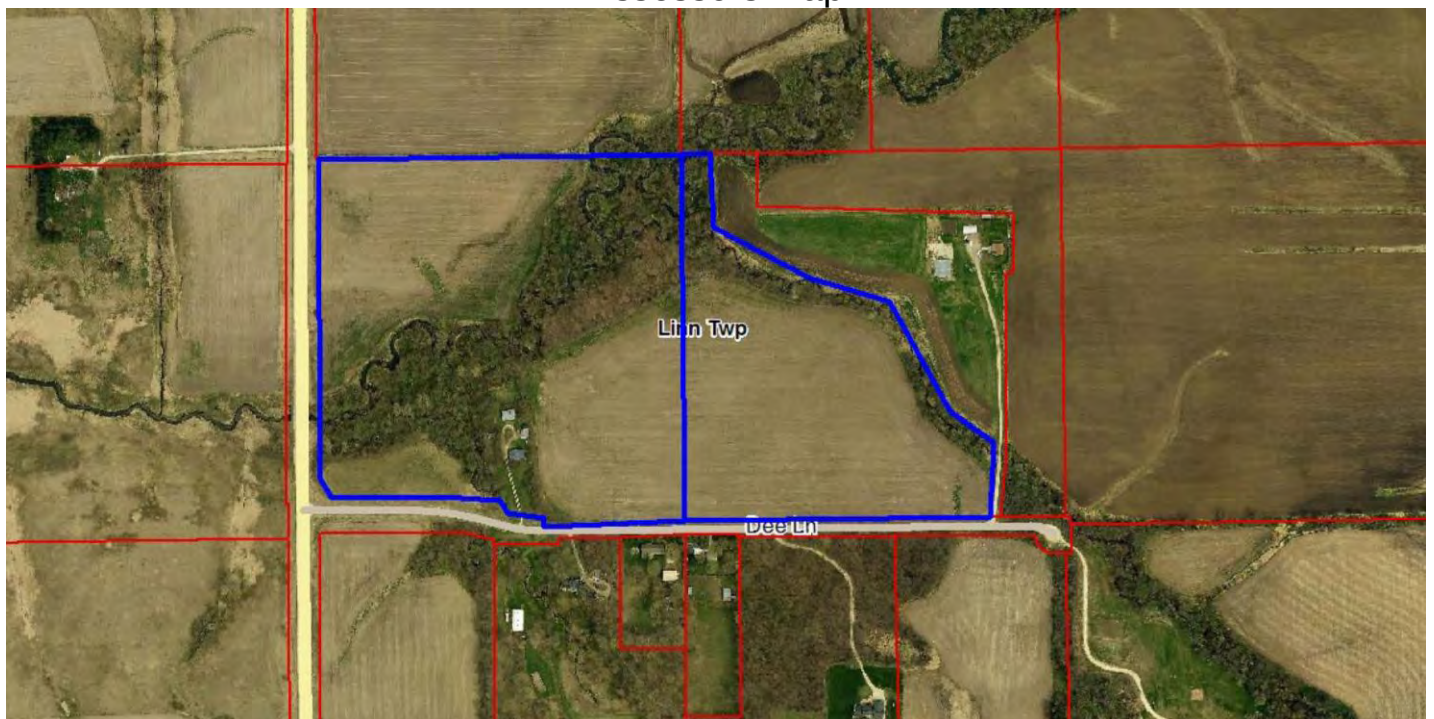

Assessors Map

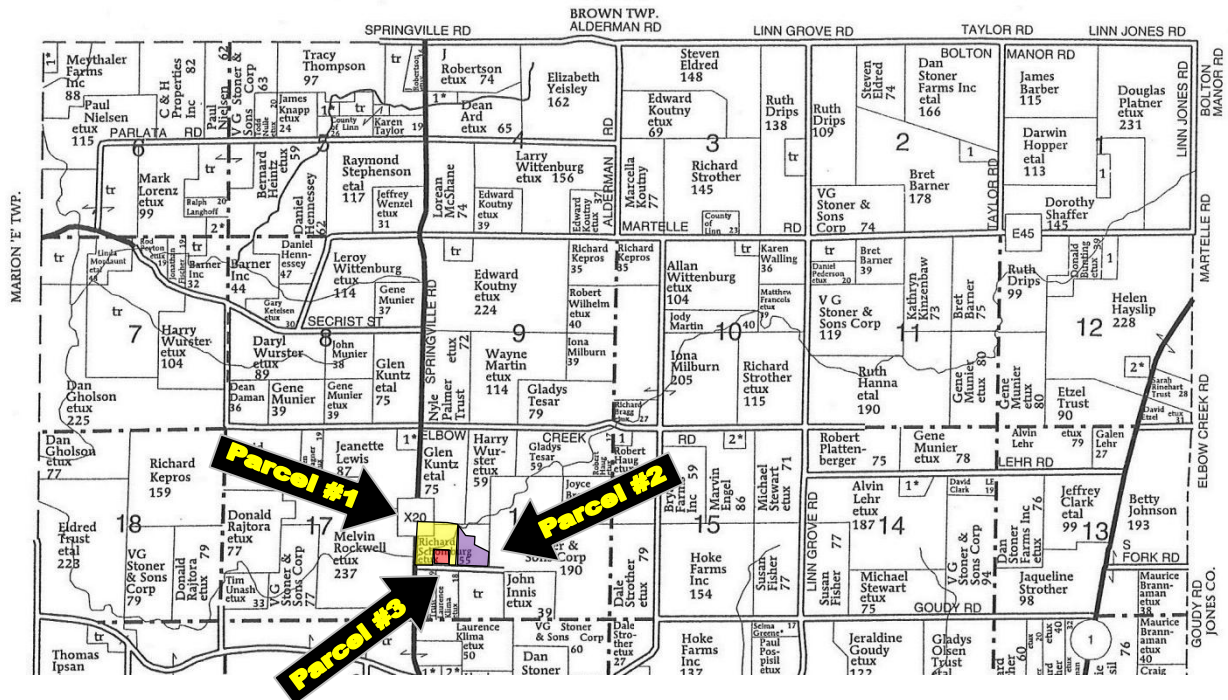

Plat Map

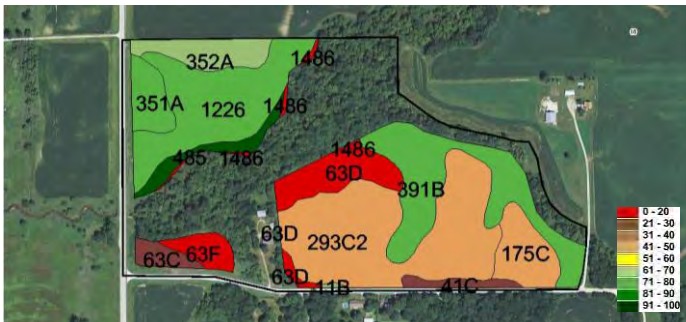
T-83-N LINN PLAT R-5-W

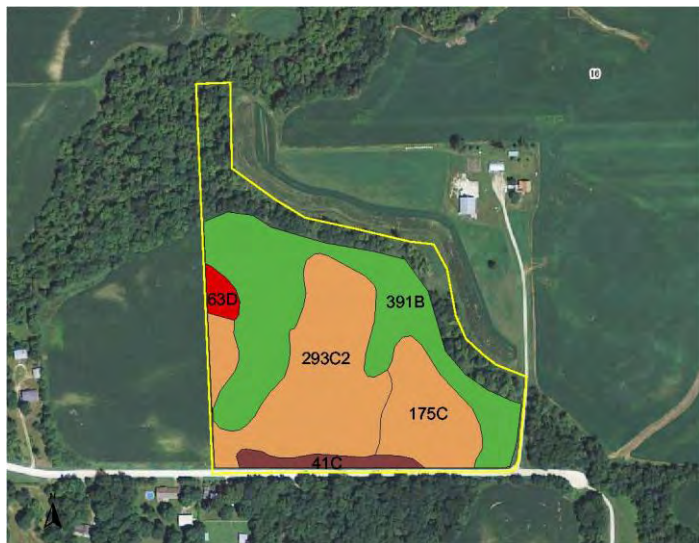
