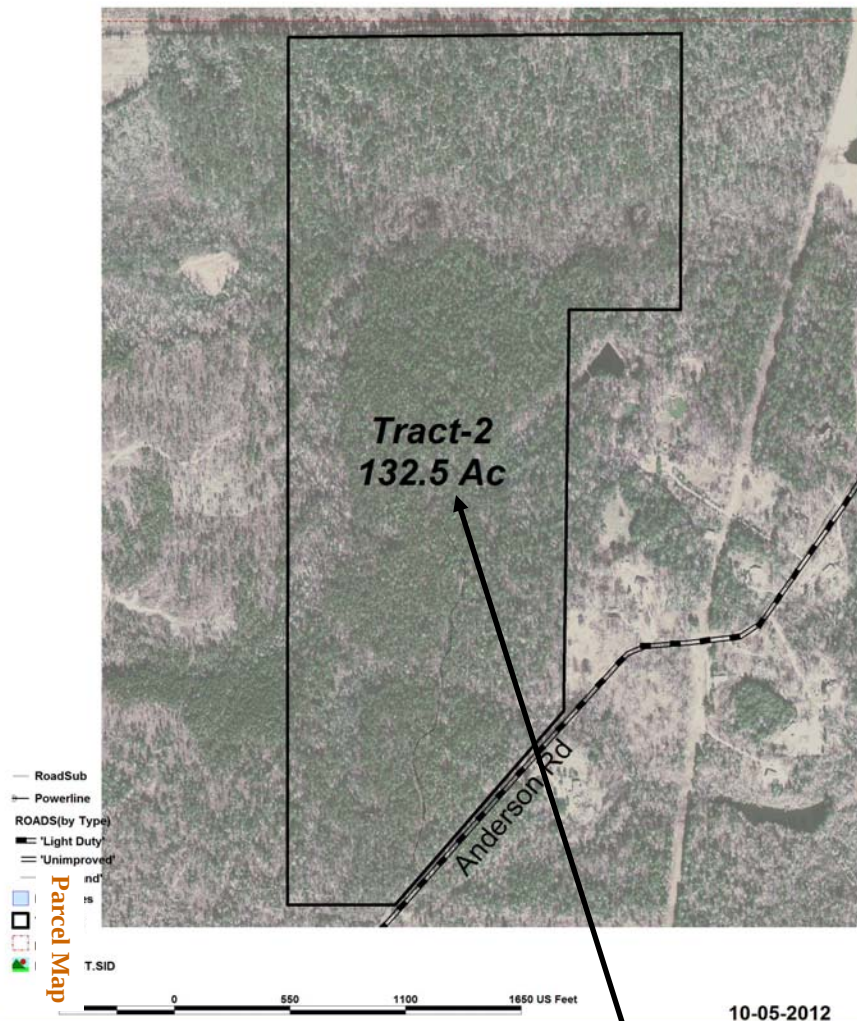

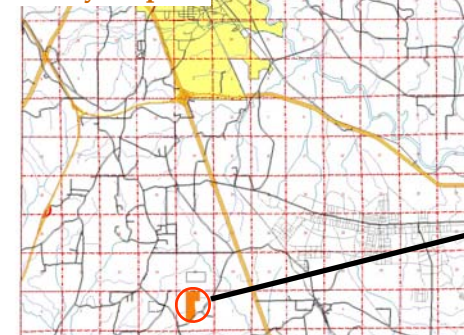

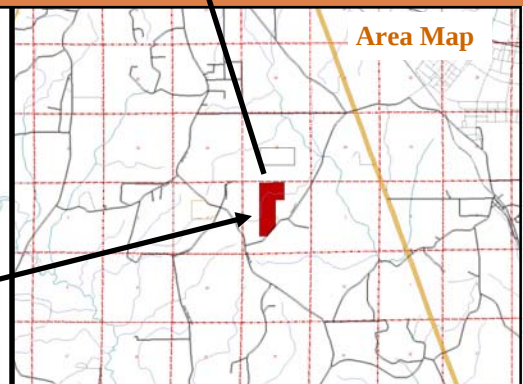

Area Map



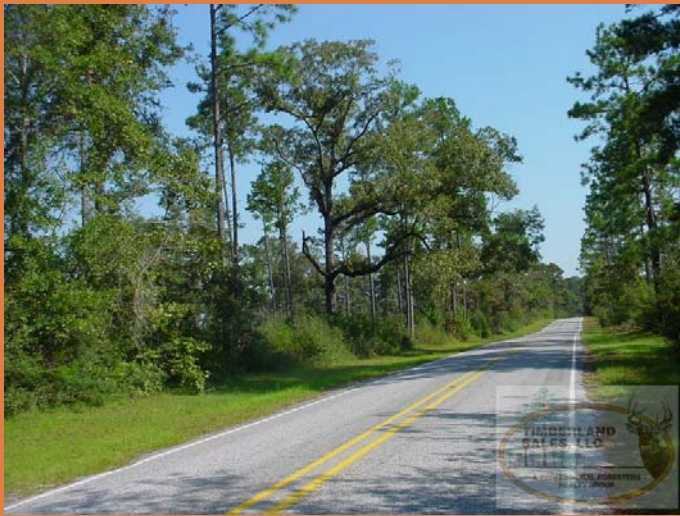
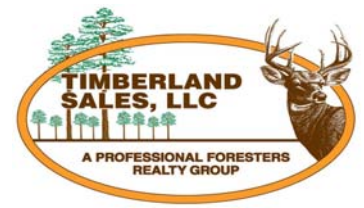

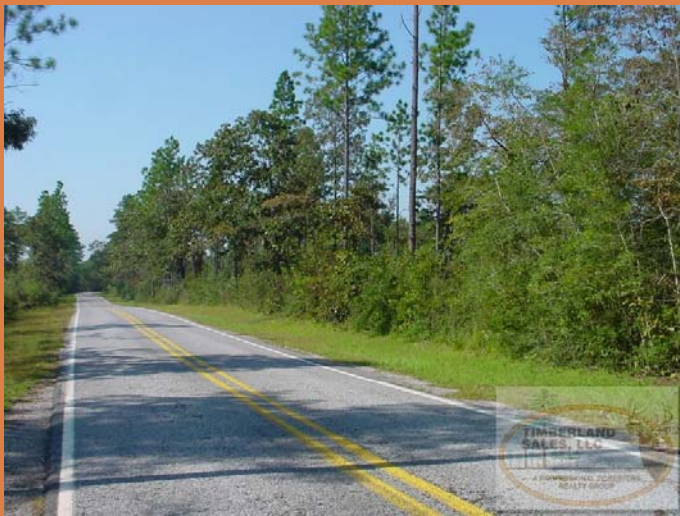
