SAID TRACT BEING MORE PARTICULALRY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING from a corner fence post at the point of intersection of the current East R.O.W. line of County Road 213 and the current South R.O.W. line of County Road 212, being the Northwest corner of the said 557.047 acre tract, the Northwest corner of a 0.3959 acre tract to be conveyed to Burnet County for additional right-of-way, and the POINT OF COMMENCMENT

THENCE S 41° 21' 47" E, through the interior of the said 557.047 acre tract and through the interior of the said 0.3959 acre tract, 18.80 feet to a ½" iron rod set at the point of intersection of a line approximately 25' East of the centerline of existing pavement of County Road 213 and a line approximately 25' South of centerline of pavement of County Road 212. - 8) N 70° 10' 38" E, 53.05 feet to a ½" iron rod set for the Northeast corner of this tract.
