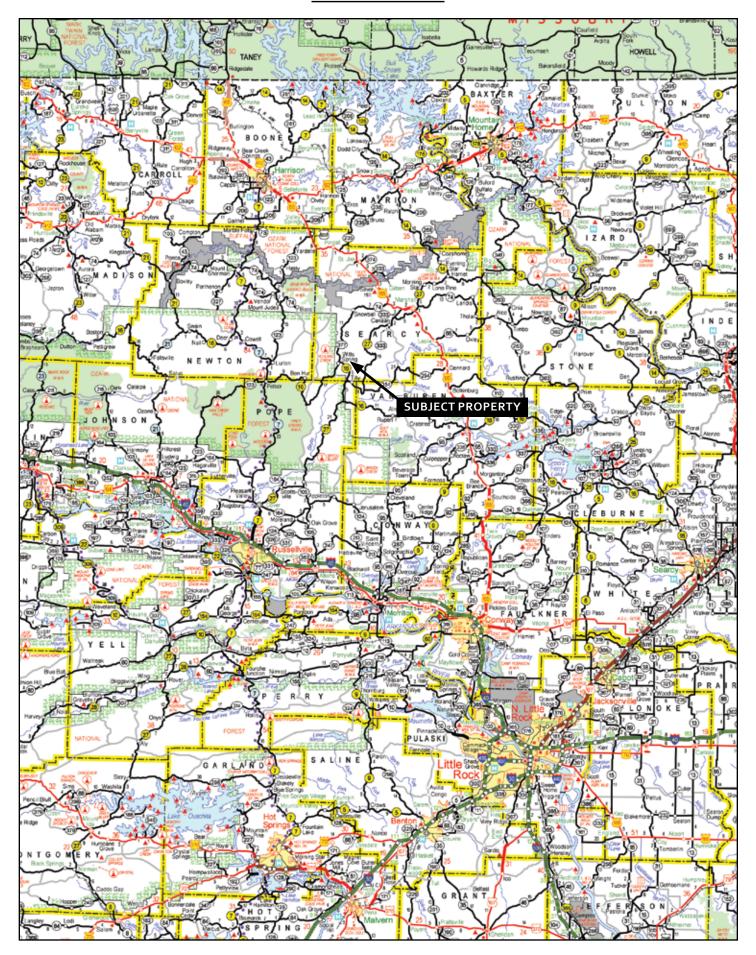

### **Description:**

Offered for sale is a "turn-key", 858 (+/-) square foot cabin on 10 (+/-) wooded acres located in Searcy County, Arkansas, in the heart of the Ozark Mountains. The cabin and grounds are in great condition and the property has been well maintained and is very secluded with expansive wilderness surrounding the location. This is the perfect outdoor, getaway place for family and friends or the establishment of a hunting club. This is the quintessential, old-fashioned, mountain cabin providing the perfect base camp for accessing state and federal lands, which offer exceptional wild turkey and deer hunting. In addition, there are other outdoor, recreational opportunities that exist within the area from fishing, floating and hiking to wildlife watching, photography or just getting away from it all. The property has an established wildlife food plot with watering pond, and bow hunting for deer is available on site. Black bear are common and local residents claim that elk, introduced to the region by the Arkansas Game and Fish Commission several years ago, are beginning to move into the area. The Buffalo National River, which is America's first national river, maintained by the United States Parks Service, provides some of the most scenic canoe floating in the county and is located within 28 miles of the property. The property also provides an amazing view of Bear Creek Canyon and many mountain ranges for miles to the northeast. There is great potential for expanding the existing cabin structure for further development. A caretaker is also available to perform property oversight and maintenance. Adjoining this property is a similar property and cabin, which is also offered for sale by the owner of this property.






### **PLAT MAP**

# **TOPOGRAPHICAL MAP**

























