BEGINNING at a 5/8 inch iron pipe found on the Northeast corner of said 25.615 acre tract, on the Northernmost Northwest corner of a 50 acre tract described in Deed to James Henry, recorded in Volume 241, Page 549 of said Deed Records, and being on the South line of a tract described in Deed to Greta Minter, recorded in Volume 231, Page 564 of said Records;

THENCE S 2° 12' 00" E along the fenced East line of said 25.615 acre tract and the West line of said 50 acre tract - 1673.39 feet to a 5/8 inch iron pipe found on the Southeast corner of said 25.615 acre tract and the Northeast corner of a 15 acre tract described in said Henry Deed;

THENCE N 69° 41' 40" W along the fenced South line of said 25.615 acre tract and the North line of said 15 acre tract - 628.37 feet to a 5/8 inch iron pipe found on the Southwest corner of said 25.615 acre tract and on the Southeast corner of a 25.616 acre tract described in Deed to Martha Jo Price, recorded in Volume 169, Page 543 of said Records:

THENCE N 140 15' 29" W along the fenced West line of said 25.615 acre tract and the East line of said 25.616 acre tract - 1456.30 feet to a 1/2 inch iron rod set on the Northwest corner of said 25.615 acre tract, on the Northeast corner of said 25.616 acre tract, and being in County Road No. SE 4433;

THENCE in an Easterly direction along the North line of said 25.615 acre tract: S 89° 49' 42" E - 147.41 feet (leaving said Road) and N 86° 39' 00" E - 737.60 feet to the PLACE OF BEGINNING containing 25.567 acres.

I, Lynn Swanner, Registered Professional Land Surveyor, do hereby certify that this survey was made on the ground under my supervision and is correct and that there are no visible encroachments, protrusions, or easements except as shown on survey plat, and that said property has access to and from a public roadway.
