If there were no protests at the hearing before the Planning Commission, and you do not desire to appeal, you may consider the Decision of the Planning Commission as final now. If the Planning Commission granted a variance or special use permit and no appeal is taken by the applicant or a protestant and as a consequence said decision becomes final, the attached decision shall constitute the variance or special use permit granted by the Commission.
