SECTION ONE REQUIREMENTS

The following requirements must be met:

- (A) Pay the agreed amounts for the interest in the land and/or the mortgage to be insured.
- (B) Pay us the premiums, fees and charges for the policy.
- (C) Documents satisfactory to us creating the interest in the land and/or the mortgage to be insured must be signed, delivered and recorded.
- (D) You must tell us in writing the name of anyone not referred to in this Commitment who will get an interest in the land or who will make a loan on the land. We may then make additional requirements or exceptions.
- (E) Taxes due and payable in the year 2011 in the amount of \$1,022.00 are half paid.

 - Property is non-homestead (for taxes due and payable in the year 2011)
- (F) Payment of the **DELINQUENT** 2nd half 2011 real estate taxes, plus interest and penalties.
- (G) The application for title insurance does not give the name of the prospective purchaser. When such name is ascertained, the records must be searched for possible judgments. If the purchaser is to be an entity other than a natural person or persons, certain additional requirements may be necessary.
- (H) Obtain and submit to the Company for recording a Warranty Deed from Potlatch Minnesota Timberlands, LLC, a Delaware limited liability company to a buyer to be determined.
- (I) Certificate of Real Estate Value.
- (J) Well Disclosure Certificate; or Deed which contains the following statement:
 - "The Seller certifies that the Seller does not know of any wells on the described real property."
- (K) This Commitment was prepared from the public records. No Abstract was furnished for examination, and none will be provided to any party without additional charge.
- (L) Provide this Company with a properly completed and executed Owner's Affidavit.
- (M) Company Affidavit by Purchaser and/or Mortgagor executed by a buyer to be determined.
- (N) If an Owner's Policy of title insurance is not ordered at the closing, Company's "Notice of Availability of Owner's Title Insurance" form must be signed by the mortgagors.

- (O) The Owner's Policy will be issued for the value of the vacant land only. If that land is to be improved and if it is desired that the improved value be insured (for additional charges) the Company must receive a written request to insure the improved value prior to closing. A pending disbursement clause will then be added as an Exception in the Owner's Policy.
- (P) The "gap period" will be insured, if this transaction is closed by First American Title Insurance Company or its affiliates. The gap refers to the gap from the effective date of this commitment to the closing date and the gap from the closing date to the recording date of the instrument to be insured.
- (Q) This Commitment is for the exclusive use of this Company and its affiliates in closing the transaction described herein. Anyone else closing off this Commitment shall be liable to this Company for all loss and damage, including payment of all charges shown on the Memo of Charges attached hereto.

SECTION TWO

EXCEPTIONS

2. Any encroachments, measurements, party walls, or other facts which a correct survey of the premises would show.
3. Rights or claims of parties in possession not shown by the public records.
4. Easements, or claims of easements, not shown by the public records.
5. Any lien, or right to lien, for services, labor, or material heretofore or hereafter furnished, imposed by law and not shown by the public records.
6. All assessments and taxes due and payable in 2011 , and thereafter.
7. No coverage is provided for municipal code compliance matters and fees, including, but not limited to, utilities, water, or sewer services, or fees for tree, weed, grass and snow or garbage removal, police boarding, vacant building registration and zoning.
8. Any and all levied and/or pending assessments.
9. Any facts, rights, interests, or claims which are not shown by the public records but which could be ascertained by an inspection of said land or by making inquiry of persons in possession thereof.
10. An easement for right of way purposes in the document recorded March 18, 1970 as Doc. No. 89763 of Official Records.
11. Covenants, conditions, restrictions and easements in the document recorded August 31, 2006 as Doc. No. A149461 of Official Records, but deleting any covenant, condition or restriction indicating a preference, limitation or discrimination based on race, color, religion, sex, handicap, familial status, national origin, sexual orientation, marital status, ancestry, source of income or disability, to the extent such covenants, conditions or restrictions violate Title 42, Section 3604(c), of the United States Codes or any State Statute or Local Ordinance. Lawful restrictions under state and federal law on the age of occupants in senior housing or housing for older persons shall not be construed as restrictions based on familial status.
12. Rights of the public and others entitled to the use of that portion of the land in Schedule "A" lying within the bounds of, including but not limited to: Any street, highway, road, and/or alley; as laid out, presently used, or dedicated.

13. Water rights, claims or title to water, whether or not shown by the public records.
14. Rights of the United States of America and/or the State of Minnesota , the county, the municipality, and the public, in and to that part of the land which may be within the stream.

6. Taxes or assessments of any taxing or assessment authority which become a lien on the Land subsequent to Date of Policy.
7. Any claim, which arises out of the transaction creating the interest of the mortgagee insured by this policy, by reason of the operation of federal bankruptcy, state insolvency, or similar creditors' rights laws, that is based on:
 - (a) the transaction creating the interest of the insured mortgagee being deemed a fraudulent conveyance or fraudulent transfer; or
 - (b) the subordination of the interest of the insured mortgagee as a result of the application of the doctrine of equitable subordination; or
 - (c) the transaction creating the interest of the insured mortgagee being deemed a preferential transfer except where the preferential transfer results from the failure:
 - (i) to timely record the instrument of transfer; or
 - (ii) of such recordation to impart notice to a purchaser for value or a judgment or lien creditor.
8. Any claim of invalidity, unenforceability or lack of priority of the lien of the Insured Mortgage as to advances or modifications made after the Insured has Knowledge that the vestee shown in Schedule A is no longer the owner of the estate or interest covered by this policy. This exclusion does not limit the coverage provided under insuring provision 7.
9. Lack of priority of the lien of the Insured Mortgage as to each and every advance made after Date of Policy, and all interest charged thereon, over liens, encumbrances and other matters affecting title, the existence of which are Known to the Insured at:
 - (a) The time of the advance; or
 - (b) The time a modification is made to the terms of the Insured Mortgage which changes the rate of interest charged, if the rate of interest is greater as a result of the modification than **it would have** been before the modification.
 This exclusion does not limit the coverage provided under insuring provision 7.

SCHEDULE B

This policy does not insure against loss or damage (and the Company will not pay costs, attorneys' fees or expenses) which arise by reason of:

1. Environmental protection liens provided for by the following existing statutes, which liens will have priority over the lien of the Insured Mortgage when they arise: MS514-67.
