


Driving Directions: From Hwy. 70 / Hwy. 8 Junction at Glenwood, go west on Hwy. 70 for approximately 0.6 mile. Turn RIGHT (NORTH) onto Vaughn Road just after you cross Sweetwater Creek bridge. Go north on Vaughn Road (narrow and sharp curves along Caddo River) for approximately 0.8 mile. Stay straight on Thunder Mountain Road and continue for approximately 2.5 miles to gravel Burks Drive. Turn RIGHT (WEST) onto Burks Drive and go approx. 0.5 mile to the northeast corner of the property (marked with pink flagging). 
