

TRACT #1- LEGAL DESCRIPTION

THE SURFACE ONLY OF: Lots One (1), Two (2), Three (3) and Four (4), and the South Half of the North Half (S/2, N/2) of Section One (1), Township Four (4), Range Twenty-three (23) WIM and Lot One (1), Section Two (2), Township Four (4) North, Range Twenty-three (23) WIM

THE SURFACE ONLY OF: The South Half (S/2) of Section One (1), Township Four (4) North, Range Twenty-three (23) WIM and The Southeast Quarter of the Southeast Quarter (SE4 SE4) of Section Two (2), Township Four (4) North, Range Twenty-three (23) WIM.

All native pasture of rolling hills and canyons, with approximately 110 acres of old CRP fields on the river bottom; program contract expired so they can be put back in cultivation, if desired. Four ponds, three water wells (need servicing). Lots of grass; fenced for running cattle, with a set of working pens.

Located on the paved CR 1480, a few miles west of Mangum. Fish Creek, a springfed live creek, runs through two quarters. Nice topography change, hills, deep draws. All native country, with no cultivation. Cross fenced for cattle, with working pens, one water well, and three ponds. Good grass, lots of white tails, turkey, and dove.
