

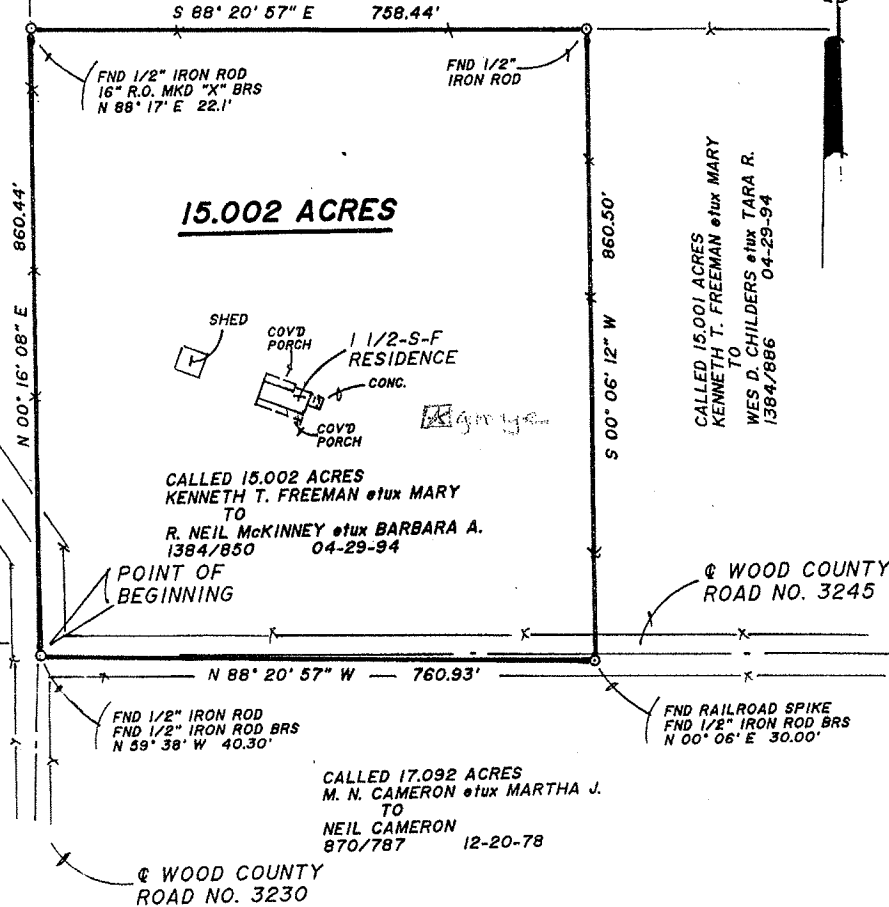

BEING all of that certain lot, tract, or parcel of land situated in the G. W. Watson Survey, Abstract No. 608, Wood County, Texas and being all of a called 15.002 acre tract described in a Deed from Kenneth T. Freeman and wife Mary Freeman to R. Neil McKinney and wife Barbara A. McKinney dated April 29, 1994 as shown of record in Volume 1384, Page 850, Real Property Records, Wood County, Texas, said 15.002 acre tract being a part of a called 50.003 acre tract described in a Deed from The First National Bank of Quitman to Kenneth T. Freeman dated May 3, 1991 as shown of record in Volume 1237, Page 703, Real Property Records, Wood County, Texas, said lot, tract, or parcel of land being more particularly described by metes and bounds as follows:

BEGINNING at a railroad spike found at the Southwest corner of said 15.002 acre tract and the Southwest corner of said 50.003 acre tract and in or near the centerline intersection of Wood County Road No. 3245 and Wood County Road No. 3230 and in the called West line of said Watson Survey, a 1/2 inch iron rod found for a witness marker bears N 59° 38' 00" W a distance of 40.30 feet;

THENCE N 00° 16' 08" E along the West line of said 50.003 acre tract and the occupied West line of said Watson Survey, a distance of 860.44 feet to a 1/2 inch iron rod found at the Northwest corner of said 15.002 acre tract and the Southwest corner of a called 20.000 acre tract described in a Deed from Clyde William Graves and wife Donna Richard Graves to Joseph L. Petronella and wife Phyllis Ann Petronella dated November 25, 1998 as shown of record in Volume 1643, Page 46, Real Property Records, Wood County, Texas, a 16 inch Red Oak marked "X" bears N 88° 17' E a distance of 22.1 feet;

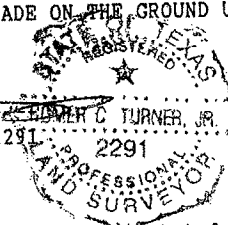
THENCE S 88° 20' 57" E along the South line of said 20.000 acre tract, a distance of 758.44 feet to a 1/2 inch iron rod found at the Northeast corner of said 15.002 acre tract and the Northwest corner of a called 15.001 acre tract described in a Deed from Kenneth T. Freeman and wife Mary Freeman to Wess D. Childers and wife Tara R. Childers dated April 29, 1994 as shown of record in Volume 1384, Page 886, Real Property Records, Wood County, Texas;

THENCE S 00° 06' 12" W along the West line of said 15.001 acre tract, a distance of 860.50 feet to a railroad spike found at the Southeast corner of said 15.002 acre tract and the Southwest corner of said 15.001 acre tract in the South line of said 50.003 acre tract and near the centerline of said County Road No. 3245, a 1/2 inch iron rod found for a witness marker bears N 00° 06' 12" E a distance of 30.00 feet;

THENCE N 88° 20' 57" W along the South line of said 50.003 acre tract and along said centerline, a distance of 760.93 feet to the POINT OF BEGINNING and containing 15.002 acres of land, of which approximately 0.52 acres lie within the limits of said County Road No. 3245.
