THENCE S, 45 DEG. 02 MIN. 07 SEC. W. WITH ROAD, 218.45 FEET TO A 1/2" IRON ROD FOUND FOR THE SOUTH CORNER OF TRACT;

THENCE N. 29 DEG. 58 MIN. 15 SEC. W. WITH THE WESTERLY LINE OF TRACT AND AN EASTERLY LINE OF 83.807 ACRE TRACT, 259.73 FEET TO THE POINT OF BEGINNING AND CONTAINING 1.206 ACRES OF LAND, ACCORDING TO MY SURVEY AND CALCULATIONS.
