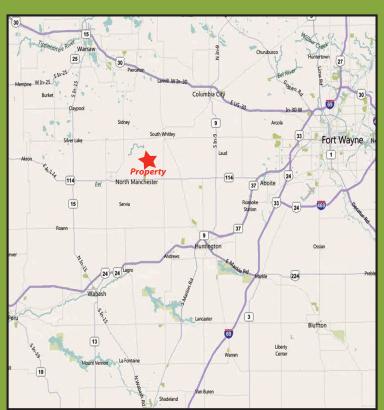

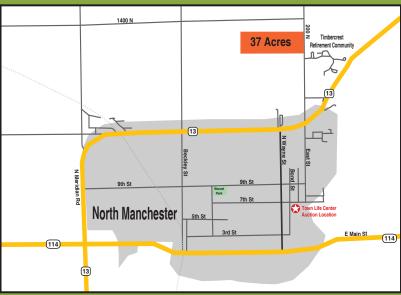

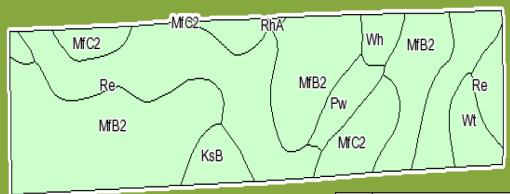
PROPERTY MAPS
