Watson as recorded in Volume 109, Page 146, Deed records of Van Zandt County, Texas and also being the same land in part as described in a deed from Lee Skinner to Ira Birdsong as recorded in Volume 457, page 37, of the Deed records of Van Zandt County, Texas and being more particularly described as follows:

BEGINNING at an iron rod set at a fence corner at the S.E. Corner of the John Conner Survey abstract #151.

THENCE, N. 89° 40' 03" W. along a fence line a distance of 810.22 feet to an iron rod set at a fence corner;

THENCE, S. 0° 10' 02" W. along a fence line a distance of 1826.71 feet to an iron rod set at a fence corner;

THENCE, N. 89° 47' 32" W. along a fence line a distance of 1376.70 feet to an iron rod set at a fence corner;

THENCE, N. 0° 01' 32" E. along a fence line a distance of 1823.24 feet to an iron rod found at a fence corner;

THENCE, N. 89° 21' 19" W. along a fence line a distance of 159.55 feet to an iron rod set at a fence corner;

THENCE, N. 0° 40 22" E. along a fence line a distance of 1014.25 feet to an icon rod set at a fence corner;

THENCE, N. 89° 51' 17" W. along a fence line a distance of BBH 19 FEET TO A POINT FOR A corner said corner being in the CENTER LINE OF FM Rd. 1652;

THENCE, N. 29° 53' 05" E. along the Centerine of FM 1652 a distance of 6/6// feet to A POINT FOR A CORNER

THENCE, S. 820 30' 35" L. along a fence line a distance of 1447.02 feet to an iron rod set at a fence corner;

THENCE, N. 00 13' 28" E. along a fence line a distance of 665.29 feet to an iron rod et at a fence corner;

THENCE, S. 79° 32' E. along a fence line a distance of 1503.99

feet to an iron rod set at a fence corner in the East line of said

John Conner Survey;

THENCE, South along a fence line and along the East line of the John Conner Survey a distance of 1762.07 feet to the Point of Beginning and containing 158.795 ACRES of Land.
