## **St. Marys Riverfront Property**

By acquiring this property, a conservation buyer is protecting its diverse natural communities while gaining an opportunity to enjoy many relaxing outdoor activities. This property supports fishing, kayaking, and canoeing in the river, while cleared trails allow for biking and hiking.

Additionally, this estate is only two miles from the Jacksonville-Baldwin Rail Trail spanning a total of 14.5 miles and providing additional opportunities for outdoor recreation and enjoying nature.

The wood frame house was constructed in 1987 and includes a full kitchen with appliances, garden bath with whirlpool tub, pine floors, and double paned windows offering spectacular views.

The 70-acre tract has approximately 2, 400 ft. of riverfront along the banks of the historic black-water St. Mary's River. A 1,576 SF residence with three bedrooms and two baths, 4 sheds with historical "old Florida" appointments, a garden, a graded driveway, and a screened patio overlooking the river enables an owner to encounter this area's natural beauty without having to sacrifice modern comforts. The property includes a variety of natural communities which are supported by the mix of uplands and wetlands and found along the river watershed.

This natural haven supports a variety of predatory birds including the southern bald eagle and the swallow tail kits as well as wading birds including the limpkin, the white ibis, and several species of heron and egret. Additionally, this area supports Sherman fox

squirrel, Florida black bear, and alligator snapping turtle.

This property has a conservation easement and has been uniquely tailored to meet the biological goals for the property. This allows one to retain private ownership while permanently conserving the wildlife habitat by limiting otherwise permissible activities. An individual who wishes to protect the environment will be able to enjoy this secluded paradise with the knowledge that he or she is preserving the river forever. The

Nature Conservancy will consider an offer that is submitted with




