



GENERAL **DESCRIPTION:** 

This unique property includes a total of 293 acres and will be offered as the north 194 acres or the south 99 acres or combined as 293 acres. Details of the parcels are as follows:

Parcel 1—194 Acres The 194 acres includes the Director's residence; two lodge buildings with dormitories, activity areas, and kitchen facilities; large hall and gathering area with restrooms; farmhouse; storage/office building; storage buildings; shelter house; and tree houses. The balance of the property is a mixture of young and mature timber, walking trails, horse trail, pond, and Skunk River frontage. There are approximately 7 acres CRP and 18 acres of cropland. This property would be ideal for a retreat center/camp/hunting lodge/recreational property.

Parcel 2—99 Acres The south 99 acres of the property consists primarily of attractive upland timber with a variety of oak, hickories and other hardwood. There are approximately 11 acres of CRP on this parcel. This would make an ideal

recreational property or weekend get away.

WATER/WELL DATA: The property is currently serviced by rural water. There is an old hand pump well near the back porch of the farmhouse

and an old well in the timber near the previous log cabin site. There is also a well between the Director's House and

Bowser Hall.

SEWER/SEPTIC: The majority of the buildings drain wastewater to a sewage lagoons. Faith Lodge has two 1,500 gallon holding tanks

and the Director's house has a septic tank and a sand filter system.

There is some land and a cabin located north of the Green Lodge that is owned by a neighboring landowner. This **EASEMENT:** 

neighboring landowner has an easement though the 194 acres for the purpose of accessing his cabin. The Buyer of this

194 acres will be responsible for maintenance, gravel, and cutting brush on this easement.

TAXES: This property is currently exempt from property tax. Non-exempt buyers should expect the property to be

placed back into the property tax rolls as of January 1, 2010.

#### PROPERTY DATA



**Director's House:** This house is a 1,504 square foot ranch with a full basement and an attached garage. The main level includes three bedrooms, 1 1/2 bath, and laundry area. The full basement has been partially finished and includes a full bathroom, storage room, two non-conforming bedrooms. The house includes a stove, refrigerator, washer and dryer.





**Bowser Hall:** Bowser Hall is the newest facility. It is a large 40' x 60' multi-purpose building perfect for gatherings, wedding receptions and speaking engagements. It is equipped to hold up to 150 people in row seating and 110 around tables. It is heated in the winter and has central air for the summer. It also comes equipped with a sink, counter space and restroom facilities.



**Faith Lodge:** Faith Lodge can house up to 44 people. This large 36' x 72' building was built around 2001 and includes central air and a large wrap around deck and a central meeting room equipped with a kitchenette. There are four large bedrooms and four bathrooms. The bathrooms all include a shower, stool and sink. This building includes a full basement which includes two full bathrooms with sink, shower, stools and a large open gathering area. This building includes two 1,500 gallon holding septic tanks.



**Green Lodge:** Green Lodge can house up to 34 people. It includes a large meeting/gathering area with a fireplace and cook area. There are bedrooms off each corner with bathrooms. The addition includes an 8' x 10' walk in cooler and two small storage rooms.

- Office/Nurses Station with restrooms and two bedrooms.
