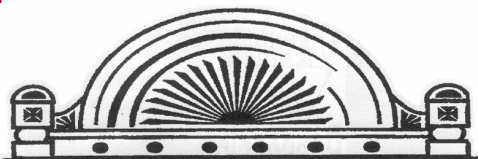

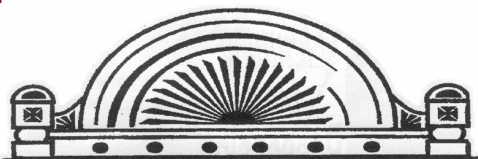
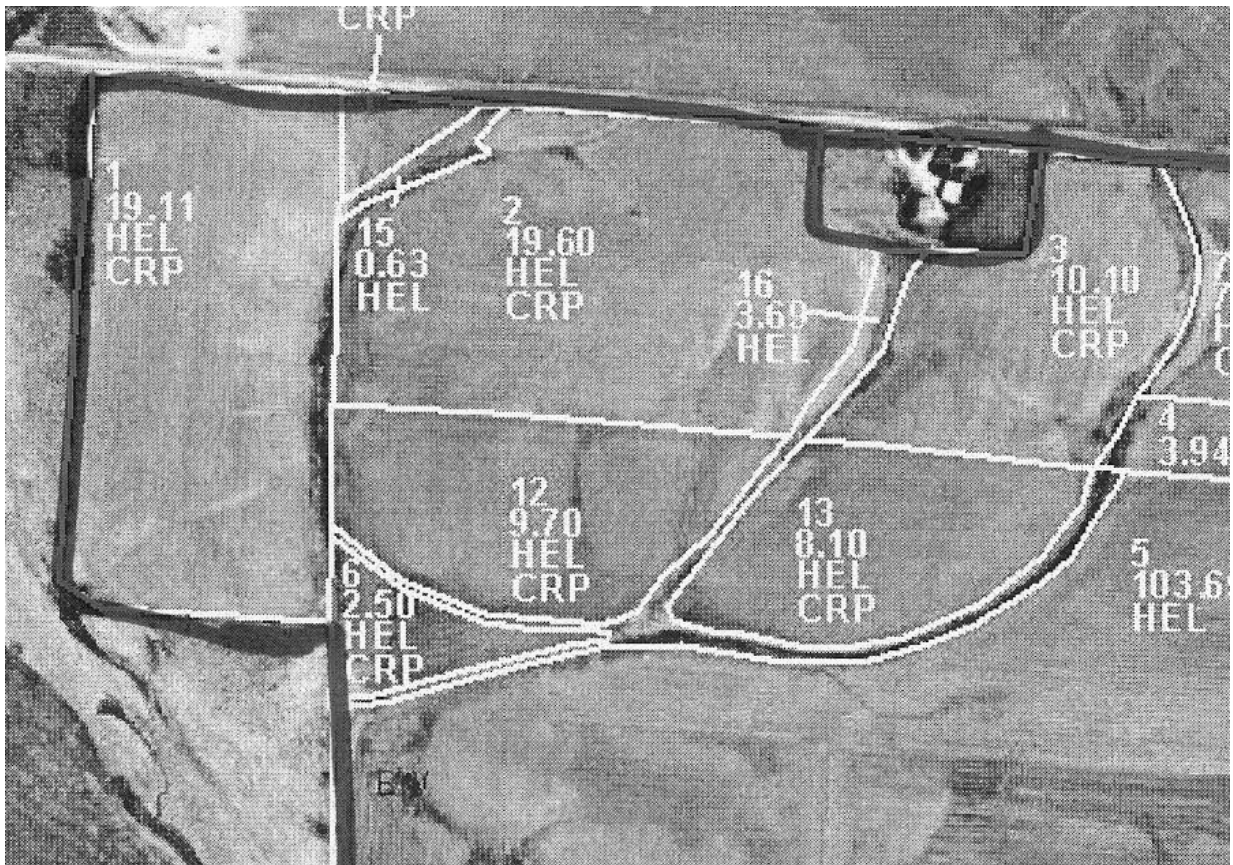


AERIAL TAX MAP



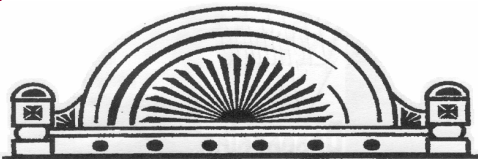

FSA MAP



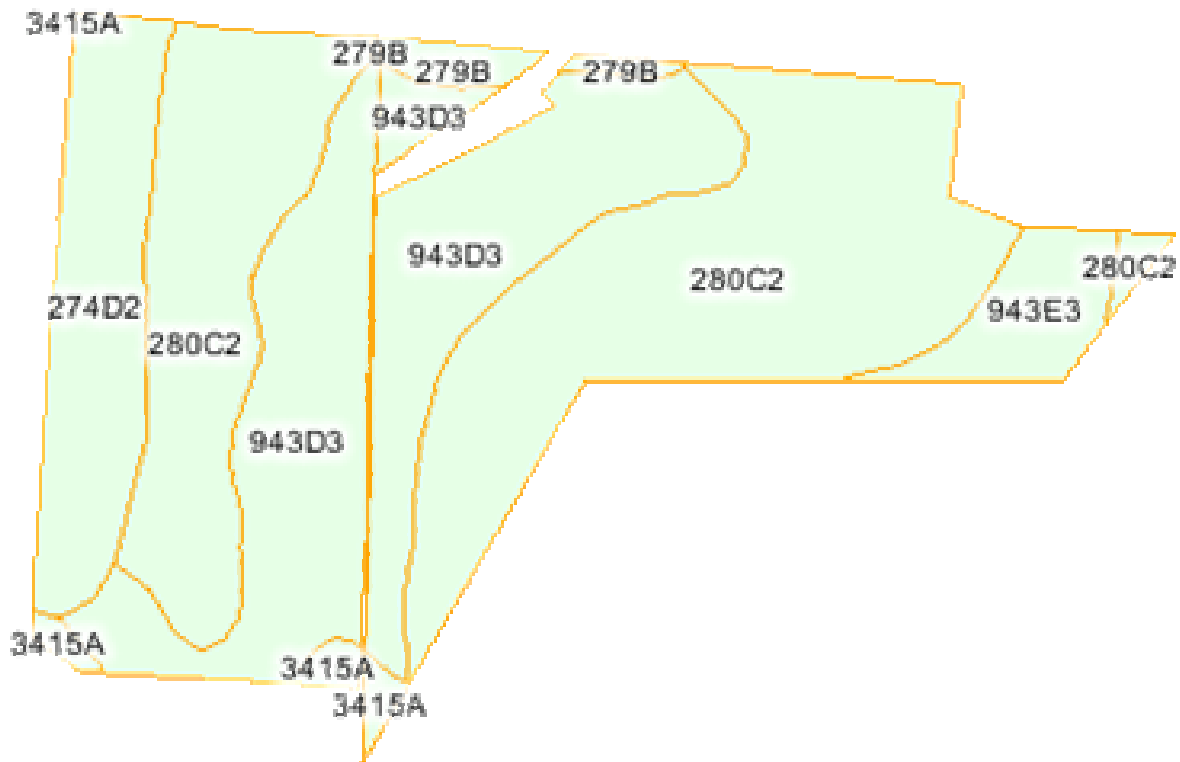

AGRIDATA AERIAL



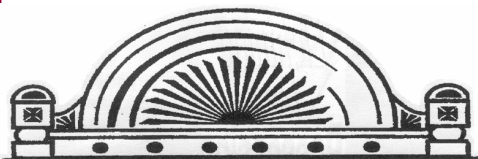

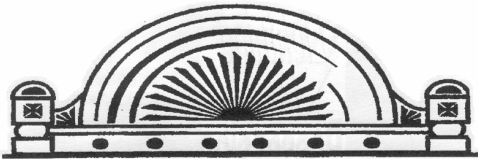
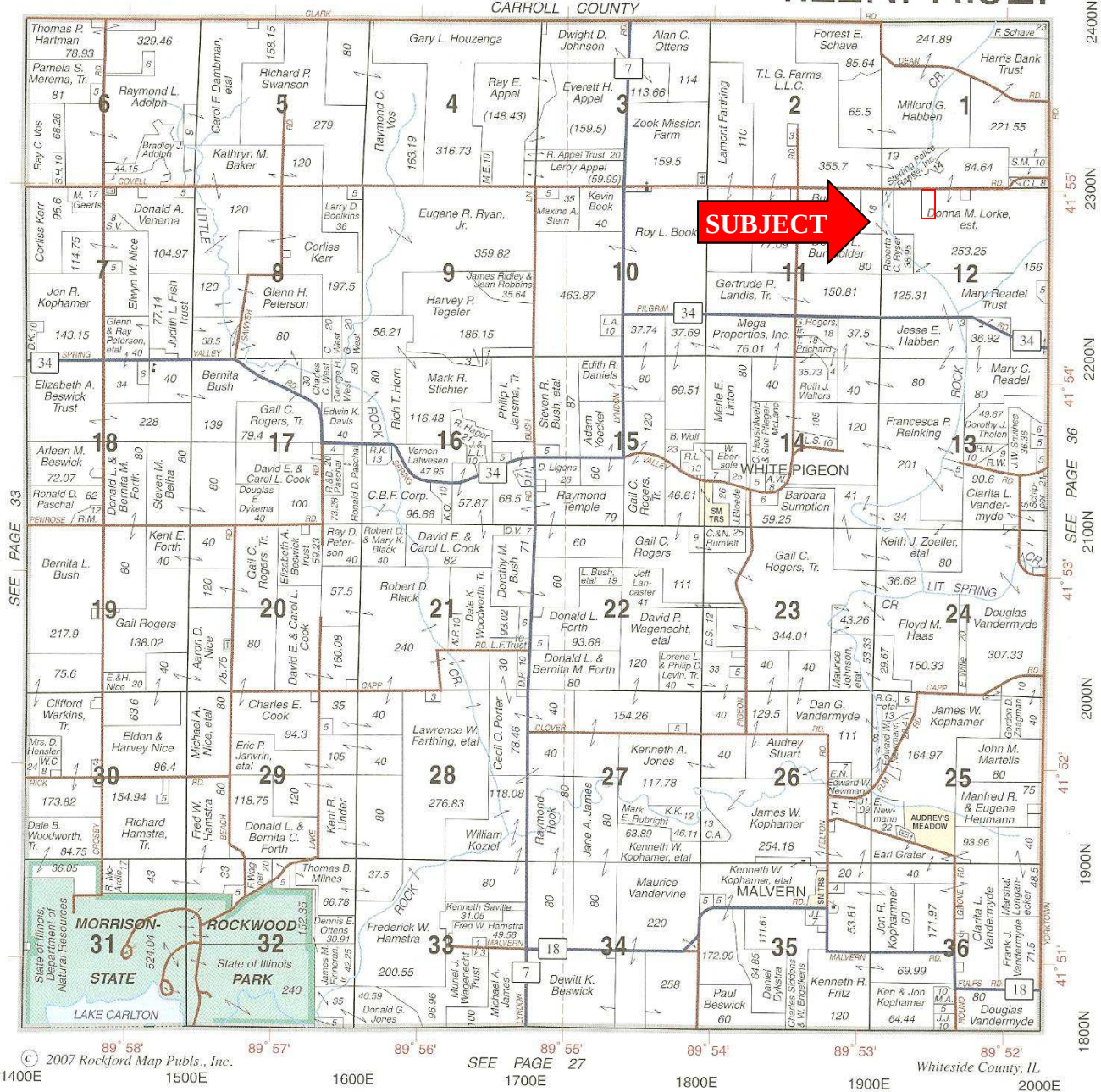

PLAT MAP

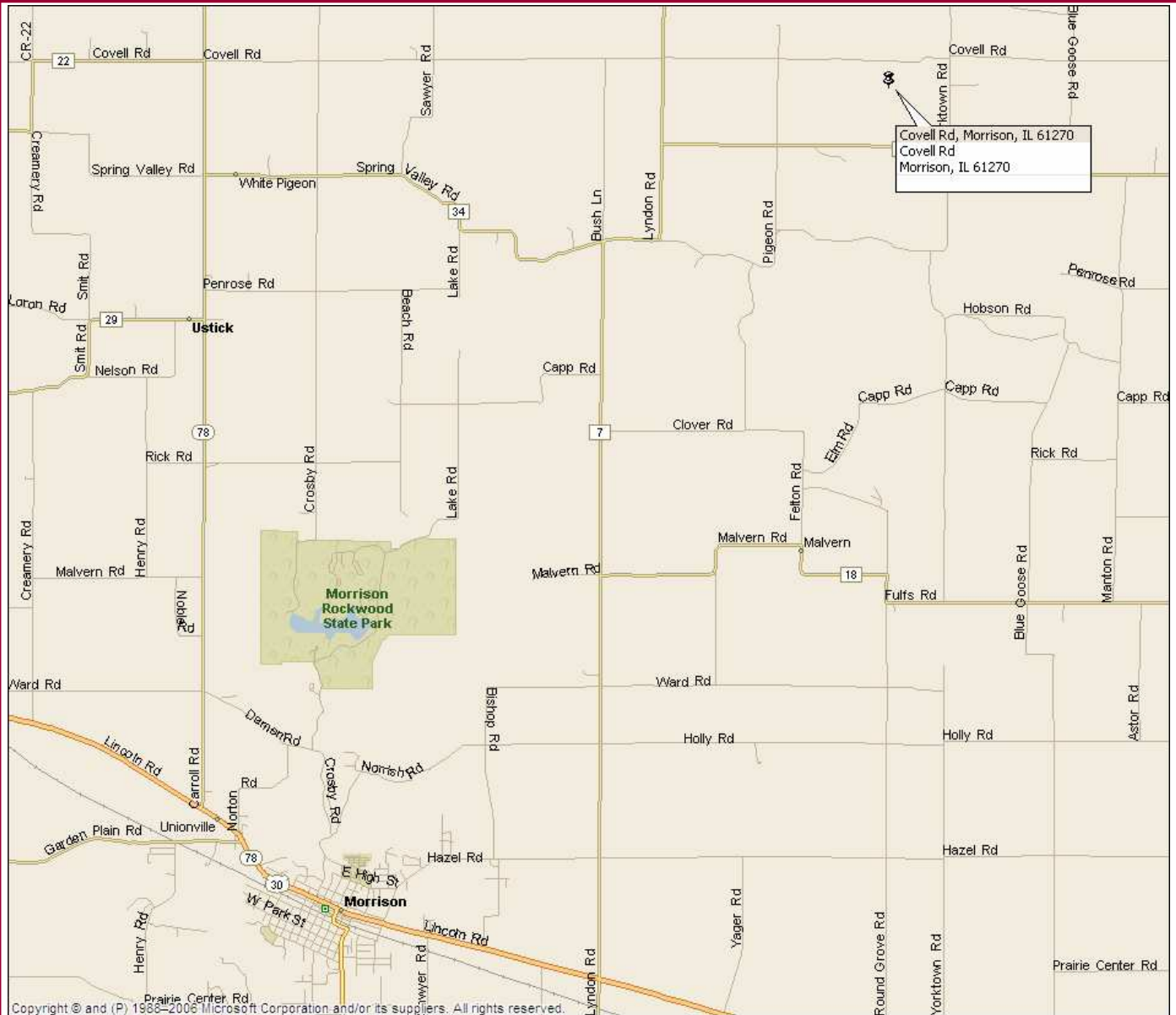

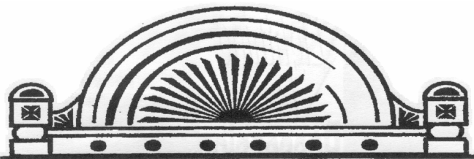
