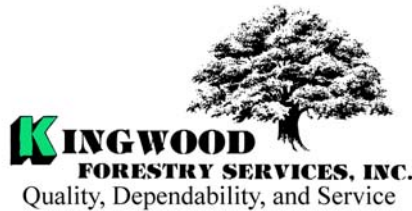

2. Offers submitted will remain valid for five (5) business days after the day of submittal. Upon acceptance of an offer a more formal Contract of Sale, with earnest money in amount of 10% of purchase price, will be executed between the successful buyer and landowner within seven business days. A sample Contract of Sale may be provided in advance upon request. Terms are cash at closing. Closing is expected to be held within thirty days of offer acceptance.
3. Only offers for a specific dollar amount will be accepted. The parcel is being sold in its entirety for a single sum and not on a per acre basis. Advertised acreage is believed to be correct, but is not guaranteed. Offer price is for entire tract, regardless of acreage. Seller will not provide a survey. The attached maps are thought to be accurate but should not be considered as survey plats.
4. Conveyance will be by Special Warranty Deed, subject to all previous mineral conveyances, reservations and exceptions, to any valid right-of-way, easements, leaseholds, and to any protective covenants or restrictions, which may have been recorded affecting the property. 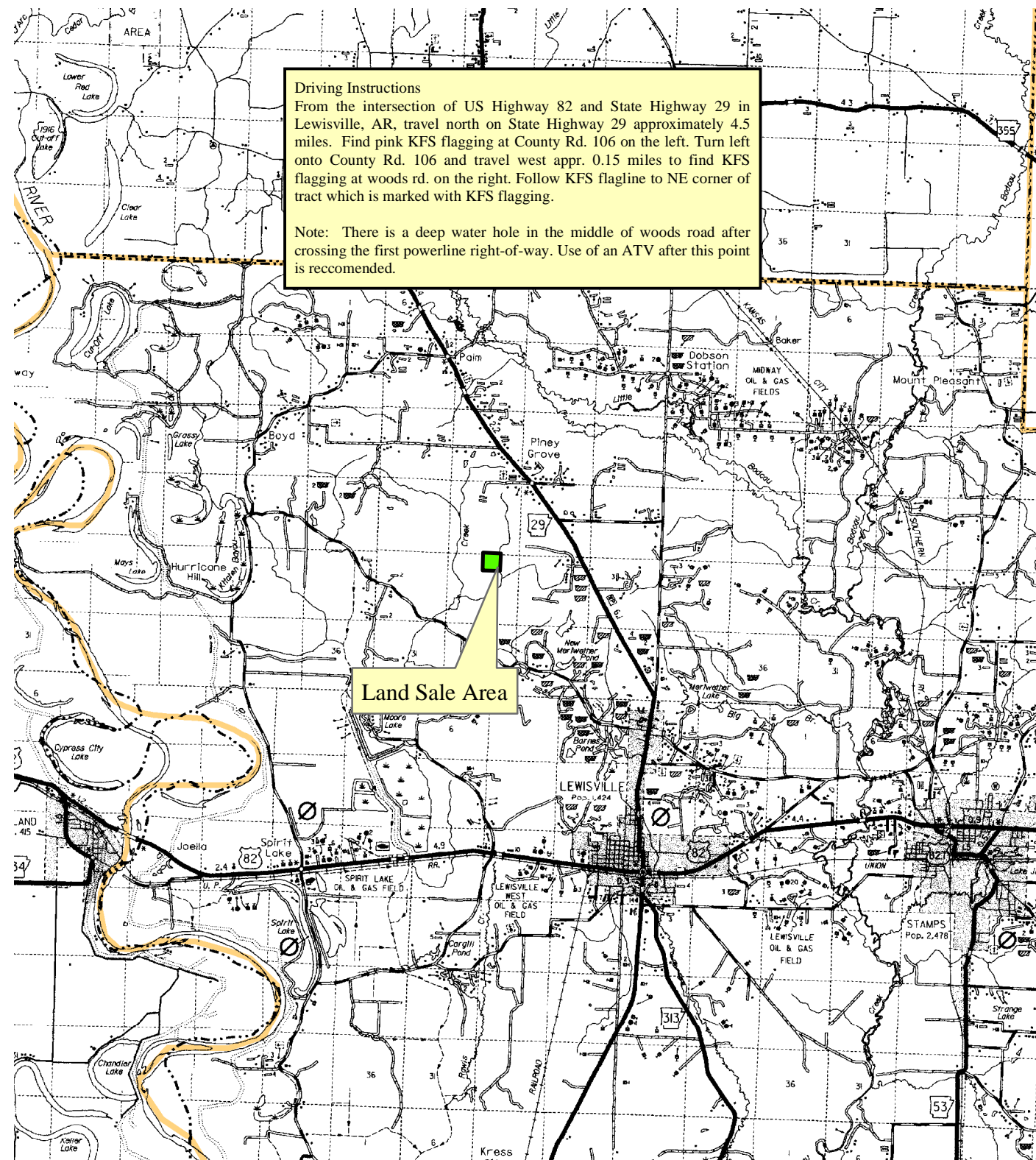

Driving Instructions

From the intersection of US Highway 82 and State Highway 29 in Lewisville, AR, travel north on State Highway 29 approximately 4.5 miles. Find pink KFS flagging at County Rd. 106 on the left. Turn left onto County Rd. 106 and travel west appr. 0.15 miles to find KFS flagging at woods rd. on the right. Follow KFS flagline to NE corner of tract which is marked with KFS flagging.

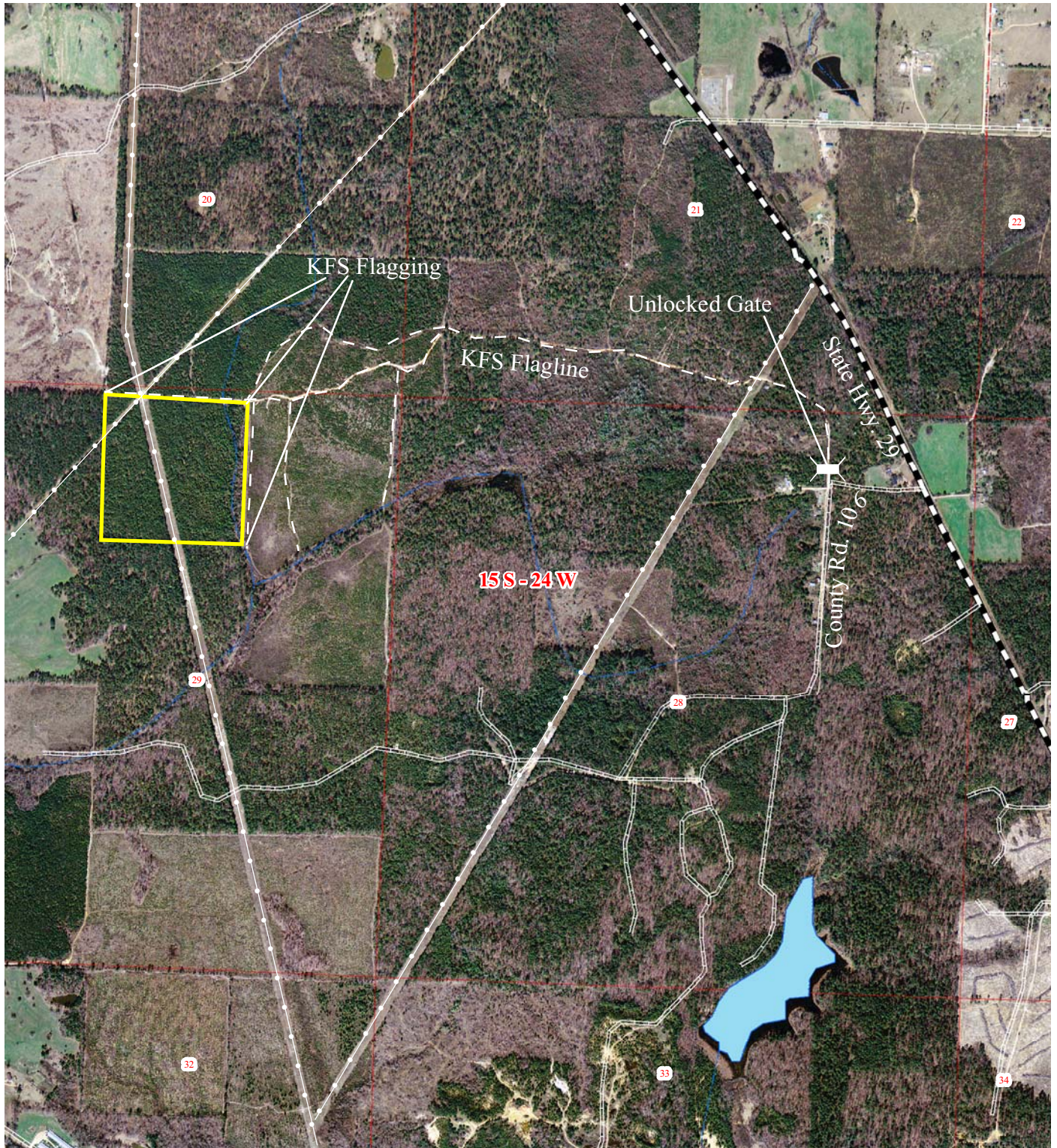
Note: There is a deep water hole in the middle of woods road after crossing the first powerline right-of-way. Use of an ATV after this point is recommended.

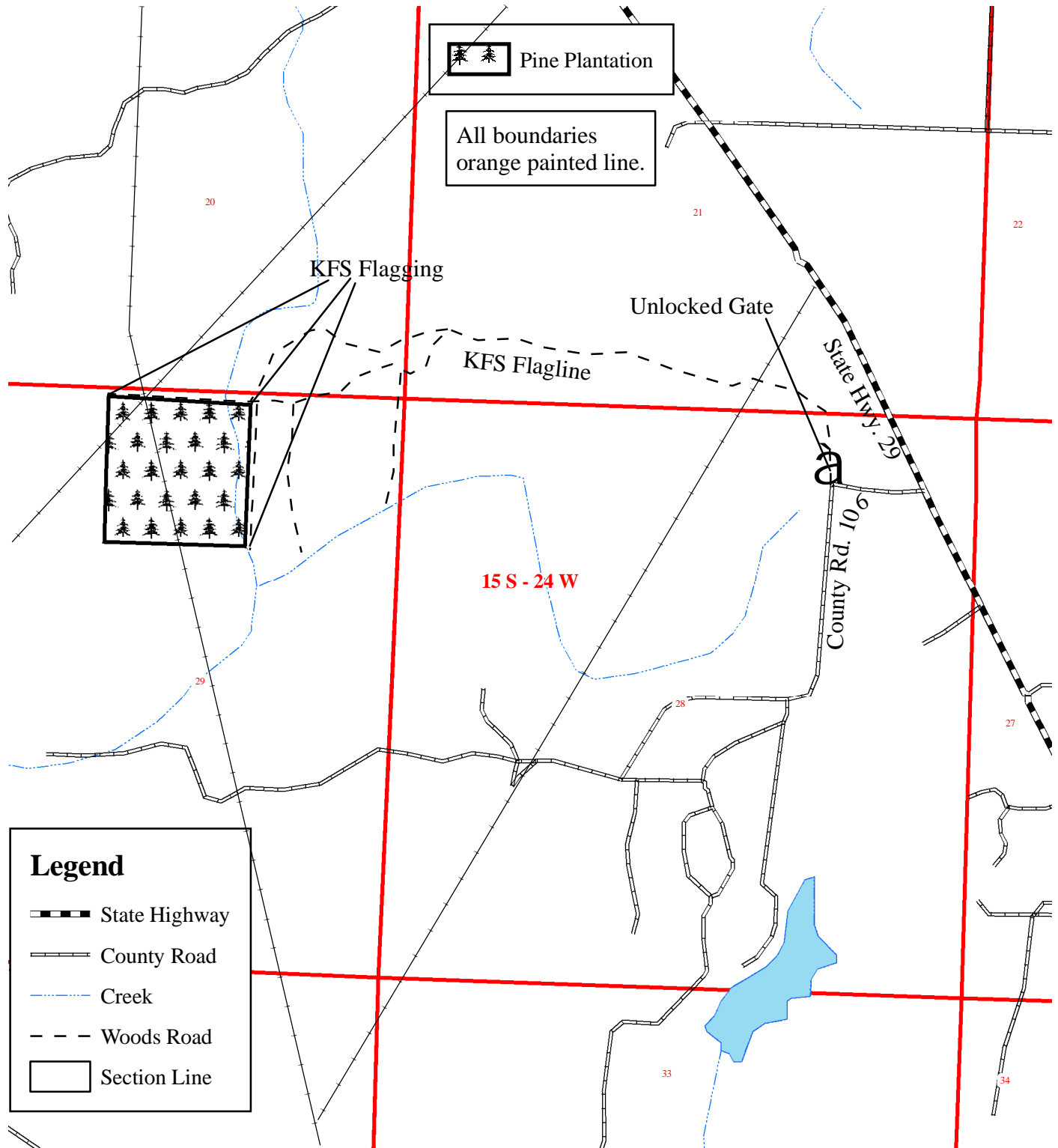

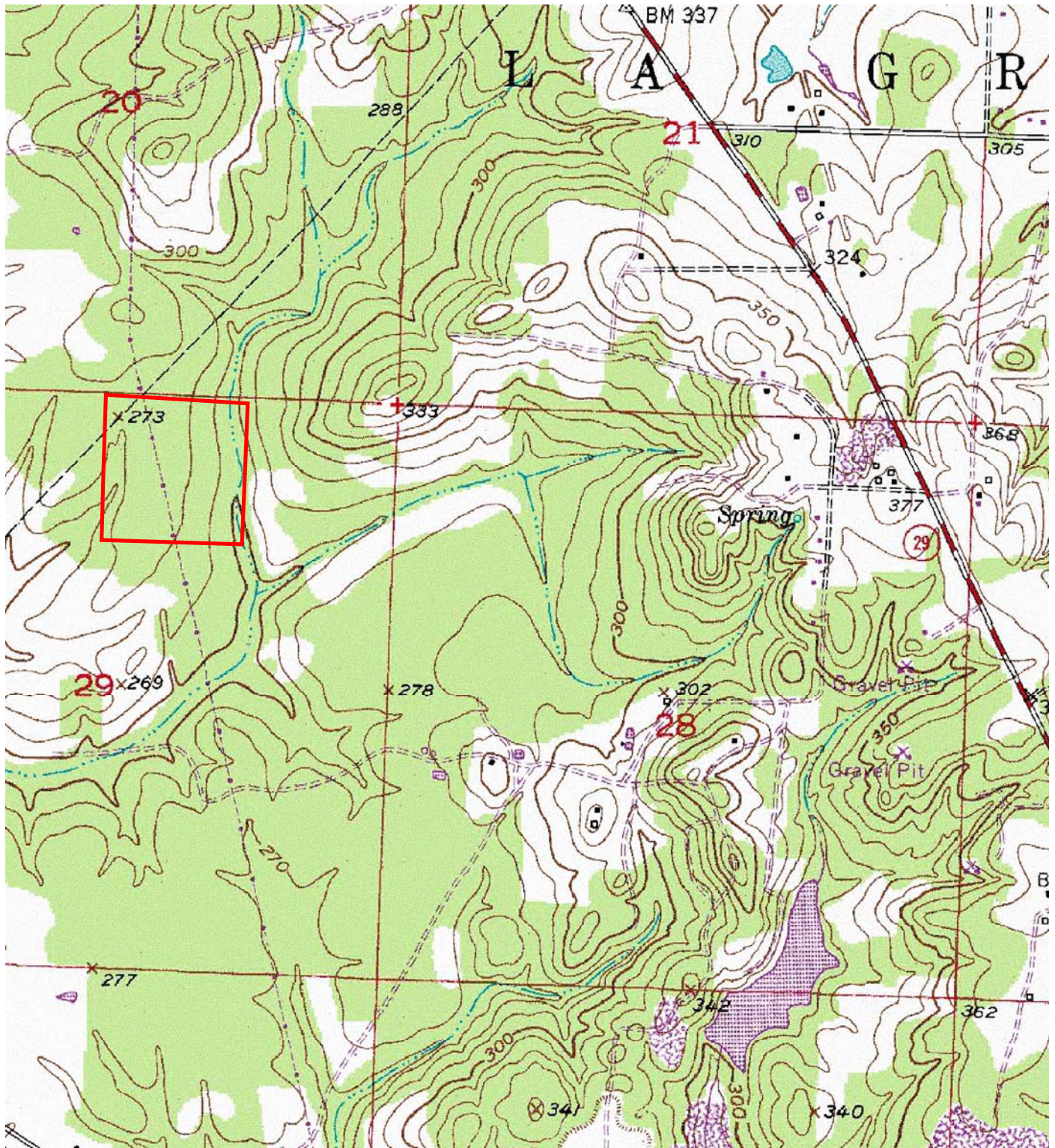
