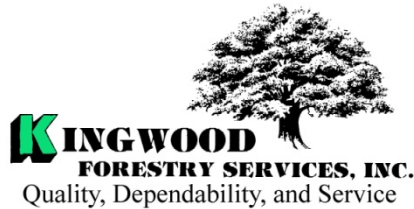

Tract Description: ATI Tract #291 is located three miles southwest of Lono. Access is via woods road off Cheatham Road. Subject contains a 2005 pine plantation with 2nd Generation Weyerhaeuser seedlings. Site preparation was aerial spray of 48 oz. Chopper plus 32 oz. Accord. Herbaceous weed control was conducted after planting. Soils consist of gravelly fine sandy loams with site index for loblolly pine averaging 80 feet on fifty year base. Terrain is rolling. 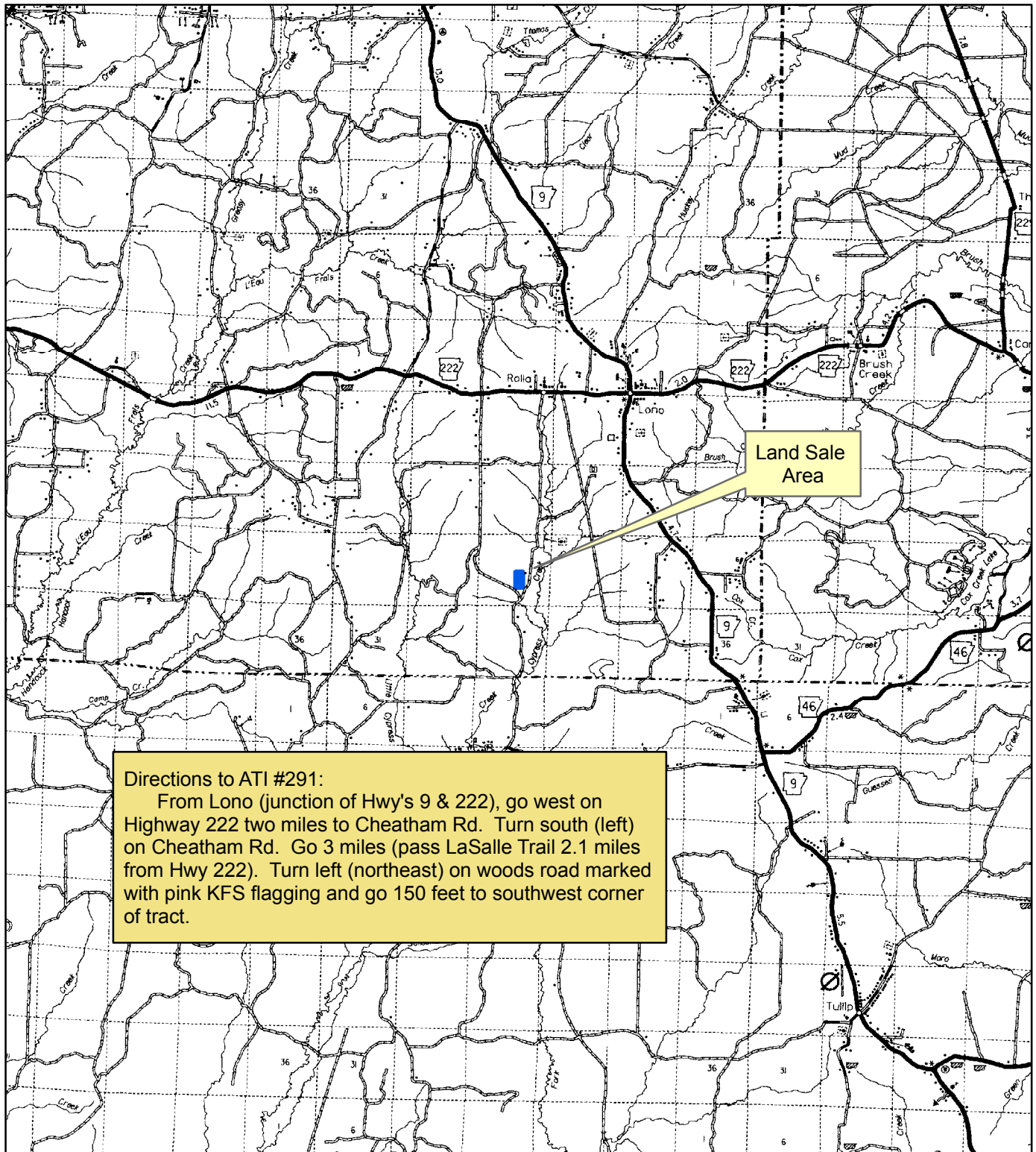
1. The landowner reserves the right to accept or reject any offer or to reject all offers.

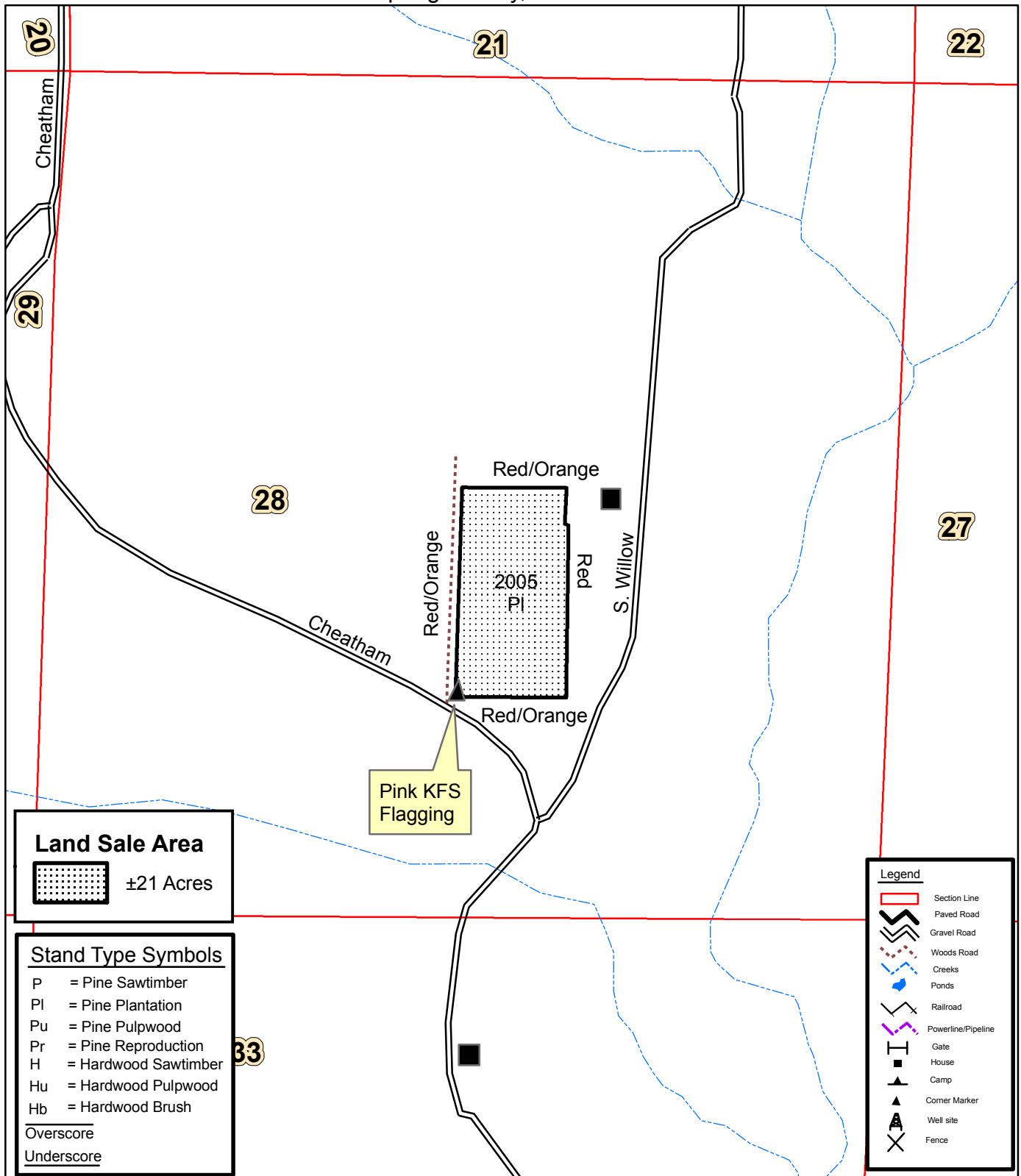
Directions to ATI #291:
