In Re: 4.252 Acres out of a 87.403 Acre Tract James Reese Survey, A-303 Milam County, Texas



All that certain tract or parcel of land situated in Milam County, Texas, being part of the James Reese Survey, Abstract No. 303 and being part of a 87.403 acre tract as conveyed from Fairview Land Company to Richard Thrasher, et ux by Deed dated December 20, 1999 and being recorded in Volume 812, Page 001 of the Official Records of said Milam County and being more particularly described by metes and bounds as follows, to wit:

<u>COMMENCING</u> an 8" steel fence corner post on the West ROW line of U. S. Highway No. 77 at its intersection with the South line of a F. M. Praesel, et ux 131 acre tract (322/225) for the Northeast corner of said original 87.403 acre tract;

THENCE with a common line between the West ROW of said U. S. Highway No. 77 and said original 87.403 acre tract as follows:

point of curvature of a curve to the left;
With said curve to the left for an arc distance of 537.07
feet, said curve having a delta of 10°29'35", a radius of

S31°14'53"W - 199.81 feet to a concrete ROW marker for an interior ell corner of this tract; S26°02'19"W - 194.66 feet to an iron pin set for the Southeast corner of this tract;
