THENCE N72-25-16W along fence, at 377.48 feet a steel pin set, the SWC of this;

THENCE N01-48-26W an unfenced line, at 1732.43 feet a steel pin set in the North line of said 100 acre tract, the NWC of this;

THENCE S70-20-32E along fence, at 95.20 feet a steel pin set at the base of a corner post, an interior corner of this;
