Location:

This quarter section of farmland is located in western Hughes County, in central South Dakota, approximately 10 miles east of Pierre. The Hughes County Farmland is uniquely located in farm, ranch, hunting and fishing country. It is situated less than 2 miles from Highway 14 on a well-maintained gravel road, giving this property access to the finer things of life and easy delivery of crops to market. The property is situated approximately three hours from regional air terminals at Rapid City, SD, Sioux Falls, SD, and Bismarck, ND.

Locale:

Hughes County is located on and adjacent to the Missouri River, with rich heritage in native culture, old west history, hunting, fishing, recreation and of course claims some of the richest farmland in the central United States. Ownership:

This farm land is owned by Leo and Mary Anne Stoner, now retired and wanting a little spending money. The Stoner family owns another 800 acres that is either close or adjacent to this quarter, 240 acres of which is similar farmland available for lease for the 2018 farm season. The successful buyer may want to negotiate both a purchase and lease.

Agronomy and Market Services:

Agriculture is by far the major industry in South Dakota and agronomy services are available from a number of local and regionally owned outlets. Grain markets are also readily available either through local markets at Pierre ten miles to the west, Onida about 26 miles to the northeast, or Harrold 25 miles to the east. All three markets have access to the rail and both Onida and Harrold have 110 car shuttle facilities.



Access:

This 160 acres of farmland lies adjacent to well-maintained 205th Street on the south with a fair weather dirt road on the east providing easy access to markets and services and community resources. Rural water and electric utilities are close and available for use or future development.

Operation:

This Hughes County farmland is currently subject to a cash lease which expires following the 2017 growing season. According to FSA records, there are 152.3 crop acres. The current crop is corn.



Soils:

This farmland is comprised of Highmore-DeGrey silt loams, Highmore-Glenham silt loams, Highmore silt loam, and Mobridge silt loam with as high as a 94 productivity index and has an impressive productivity index weighted average of 79.4 that will provide the new owner with high yields of his or her choice of crops.

Taxes:

Real estate taxes for 2016 being paid in 2017 are \$2,240.64.




