RE: Soil Evaluation in Wheatfield Township, Section 11, 2 splits East of 1636 Linn Road, Parcel # 33-07-07-11-100-002, Application # 8-22-14-192.

Dear Mr. Rosendale:

On September 16, 2014, a soil evaluation was conducted to determine the soil conditions for the above referenced property for an on-site sewage treatment system. This parcel was evaluated in anticipation of the construction of 2 single family dwellings on 2 splits east of 1636 Linn Road. The results of the evaluations are enclosed in this letter and on the attached Soil Evaluation Data Sheet.

West Split. Three backhoe cuts were made on the lot to find a suitable area for wastewater treatment. Backhoe cuts 1, 2, and 3 did meet the minimum Ingham County requirements for a conventional wastewater treatment system. Soils at this site include a sandy loam to clay loamy soil with no evidence of a seasonal high water level within 46 inches from original grade. The elevation of the sewer line out of the home must be high enough to have no more than 12 to 18 inches of cover over the top of the drainfield stone. One foot of 2ns sand may be required under the stone.

East Split. Two backhoe cuts were made on the lot to find a suitable area for wastewater treatment. Backhoe cuts 4 and 5 did meet the minimum Ingham County requirements for a conventional wastewater treatment system. Soils at this site include a sandy loam to clay loamy soil with no evidence of a seasonal high water level within 50 inches from original grade. The elevation of the sewer line out of the home must be high enough to have no more than 12 to 18 inches of cover over the top of the drainfield stone.

Both splits are also approved for a potable water supply well. A permit for a new well and septic will need to be obtained from this office with the appropriate fees. A site plan for the construction of the both homes must be submitted to this office prior to the issuance of a permit.

In closing, you are reminded to keep equipment off the area that was determined to be suitable for a sewage treatment system. Protecting the natural condition of the soils is very important to the future operation of your system. If you have any questions or concerns, contact our office at (517)887-4312.
