

Farm is located just southeast of Scranton in Section 13 of Scranton Township. Great access by paved highway County Road E53 on the north side of the property. There is drainage tile working on this property, but maps are unavailable. Farm lease is open for the 2018 year, and farm has been soil tested in 2015. Soil test report and yield data are available for interested parties.
