Field Notes Description

Being a 2.93 acre tract out of a 5.00 acre tract conveyed from Franklin Filip and Henrietta Filip to Ronnie and Nova Layton by General Warranty Deed dated February 27, 2009 and recorded in Volume 478, Page 552 of the Official records of Lavaca County, Texas, also comprised of a portion of the Samuel G. Hanks League, Abstract

Being more fully described by metes and bounds as follows:

BEGINNING: at a 5/8 inch iron rod with cap stamped "RPLS 6368" set in the north line of a 68.221 acre tract conveyed to Henrietta Ling Rehak by deed recorded in Volume 614, Page 340 of the Official Records of Lavaca County, Texas, the south line of said 5.00 acre tract, and at the southeast corner of a 2.07 acre tract (dually surveyed), for the southwest corner of this herein described tract, whence a 1/2" iron rod found at the southwest corner of said 5.00 acre tract bears N 72°57'07" W -146.19 feet

THENCE:

N 12°39'04" E -539.74 feet across said 5.00 acre tract, the east line of said 2.07 acre tract, and the west line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set in the south right of way line of F.M. Highway 532, in the north line of said 5.00 acre tract, and at the northeast corner of said 2.07 acre tract, for the northwest corner of this herein described tract;

THENCE:

S 81°44'51" E -129.11 feet along the south right of way line of said F.M. Highway 532, the north line of said 5.00 acre tract, and the north line of this herein described tract to a point, for an angle corner of this herein described tract;

THENCE:

S 83°24'34" E -97.47 feet contining along the south right of way line of said F.M. Highway 532, the north line of said 5.00 acre tract, and the north line of this herein described tract to a fence corner post found at a northwest corent of said 68.221 acre tract and the northeast corenr of said 5.00 acre tract, for the northeast corenr of this herein described tract;

THENCE:

S 12°06'42" W -577.73 feet along a west line of said 68.221 acre tract, the east line of said 5.00 acre tract, and the east line of this herein described tract to a point at an interior corner of said 68.221 acre tract and the southeast corner of said 5.00 acre tract, for the southeast corner of this herein described tract, whence a 1/2" iron rod with cap found bears N 44° 16' 04" E-0.34 feet;

THENCE:

N 72°57'07" W -231.78 feet along the north line of said 68.221 acre tract, the south line of said 5.00 acret tract, and the south line of this herein described tract to the POINT OF BEGINNING, containing within these metes and bounds a 2.93 acre tract, more or less.


